RESOLUTION

1 WHEREAS, The Honorable Carolyn Jones is retiring as mayor of 2 Winnsboro in May 2013, drawing to a close an exemplary 12-year 3 tenure in office; and

WHEREAS, A longtime resident of Winnsboro, Carolyn Jones 4 5 first developed an interest in local government while attending city council meetings in 1995; she went on to contribute to the area 6 7 chamber of commerce and, just prior to running for office, helped to found the Winnsboro Center for the Arts; her early civic 8 involvement further included memberships in the Winnsboro Economic 9 Development Corporation, the planning and zoning board, and the 10 11 Winnsboro Humane Society, for which she played a vital role in 12 raising funds to open a new shelter; and

13 WHEREAS, The longest-serving mayor in the history of 14 Winnsboro, Mrs. Jones won election in 2001, and has since shared her insight on a number of boards while overseeing substantial 15 16 infrastructure improvements; she recommended having a wastewater plant retrofitted rather than replaced, thereby saving the city 17 18 \$1.5 million, and she oversaw the highly successful sesquicentennial celebration in 2004, as well as Winnsboro's 19 designations as a Main Street City and a Certified Retirement 20 21 Community; and

22 WHEREAS, Mayor Jones has additionally given of her time as 23 president of Region 15 of the Texas Municipal League, pageant chair 24 of Miss Texas, and a member of the Autumn Trails Board of Directors;
