## A BILL TO BE ENTITLED AN ACT

1**-**17 1**-**18 relating to unemployment compensation eligibility and chargebacks regarding certain persons who are victims of sexual assault. 1-19

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Subsection (a), Section 204.022, Labor Code, is 1-21 amended to read as follows:

1-22 1-23 (a) Benefits computed on benefit wage credits of an employee or former employee may not be charged to the account of an employer if the employee's last separation from the employer's employment 1-24 1-25 before the employee's benefit year: 1-26

was required by a federal statute; (1)

(2) was required by a statute of this state or an ordinance of a municipality of this state; 1-27 1-28

1-29 (3) would have disqualified the employee under Section 1-30 207.044, 207.045, 207.051, or 207.053 if the employment had been 1-31 the employee's last work;

SECTION 6. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.
