10	Sec. 155.103. MILITARY LIMITED VOLUNTEER LICENSE. (a) The
11	board shall adopt rules relating to the issuance of a military
12	limited volunteer license under this section.
13	(b) The board may issue a military limited volunteer license
14	to practice medicine to an applicant who:
15	(1) is licensed and in good standing, or was licensed
16	and retired in good standing, as a physician in another state;
17	(2) is or was authorized as a physician to treat
18	personnel enlisted in a branch of the United States armed forces or
19	veterans; and
20	(3) meets any other requirement prescribed by board
21	<u>rule.</u>
22	(c) The board may not issue a license under this section to
23	an applicant who:
24	(1) holds a medical license that:

1	(A) is currently under active investigation; or
2	(B) is or was subject to a disciplinary order or
3	action or to denial by another jurisdiction;
4	(2) holds a license to prescribe, dispense,
5	administer, supply, or sell a controlled substance that:
6	(A) is currently under active investigation; or
7	(B) is or was subject to a disciplinary order or
8	action or to denial by another jurisdiction; or
9	(3) has been convicted of, is on deferred adjudication
10	community supervision or deferred disposition for, or is under
11	active investigation for the commission of:
12	(A) a felony; or
13	(B) a misdemeanor involving moral turpitude.
14	(d) A physician may practice medicine under a license issued
15	under this section only at a clinic that primarily treats indigent
16	patients. The physician may not receive compensation for medical
17	services rendered at the clinic.
18	(e) A military limited volunteer license holder is subject
19	to board rules, including rules regarding disciplinary action,
20	license registration and renewal, and continuing medical
21	education.
22	SECTION 3. This Act takes effect September 1, 2013.
