- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 521.126, Transportation Code, is amended
- 7 by amending Subsections (i), (j), and (k) and adding Subsection (1)
- 8 to read as follows:
- 9 (i) The prohibition provided by Subsection (b) does not
- 10 apply to a health care provider or hospital that accesses, uses,
- 11 compiles, or maintains a database of the information to provide
- 12 health care services to the individual who holds the driver's
- 13 license, commercial driver's license, or personal identification
- 14 certificate.
- 15 (j) Except as otherwise provided by this subsection, a
- 16 health care provider or hospital may not sell, transfer, or
- 17 otherwise disseminate the information described by Subsection (i)
- 18 to a third party for any purpose, including any marketing,
- 19 advertising, or promotional activities. A <u>health care provider or</u>
- 20 hospital that obtains information described by Subsection (i) may
- 21 transfer the information only in accordance with the rules
- 22 implementing the federal Health Insurance Portability and
- 23 Accountability Act of 1996 (Pub. L. No. 104-191). A business
- 24 associate, and any subcontractor of the business associate who

- 1 receives the transferred information, may use the information only
- 2 to service or maintain the <u>health care provider's or</u> hospital's
- 3 database of the information.
- 4 (k) If an individual objects to the <u>health care provider or</u>
- 5 hospital collecting the individual's information from the
- 6 individual's driver's license as described by Subsection (i), the
- 7 <u>health care provider or</u> hospital must use an alternative method for
- 8 collecting the individual's information.
- 9 <u>(1) In this section, "health care provider" means an</u>
- 10 individual or facility licensed, certified, or otherwise
- 11 <u>authorized</u> by the law of this state to provide or administer health
- 12 care, for profit or otherwise, in the ordinary course of business or
- 13 professional practice, including a physician, nurse, dentist,
- 14 podiatrist, pharmacist, chiropractor, therapeutic optometrist,
- 15 ambulatory surgical center, urgent care facility, nursing home,
- 16 home and community support services agency, and emergency medical
- 17 <u>services personnel as defined by Section 773.003, Health and Safety</u>
- 18 Code.
- 19 SECTION 2. This Act takes effect September 1, 2013.
