1-18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-19 SECTION 1. Section 46.002, Government Code, is amended to  
 1-20 read as follows:

1-21 Sec. 46.002. PROSECUTORS SUBJECT TO CHAPTER. This chapter  
 1-22 applies to the state prosecuting attorney, all county prosecutors,  
 1-23 and the following state prosecutors:
