- 5 SECTION 1. Subchapter F, Chapter 551, Government Code, is
- 6 amended by adding Section 551.131 to read as follows:
- 7 Sec. 551.131. WATER DISTRICTS. (a) In this section,
- 8 <u>"water district" means a river authority, groundwater conservation</u>
- 9 district, water control and improvement district, or other district
- 10 created under Section 52, Article III, or Section 59, Article XVI,
- 11 Texas Constitution.
- 12 (b) This section applies only to a water district whose
- 13 territory includes land in three or more counties.
- 14 <u>(c) A meeting held by telephone conference call or video</u>
- 15 conference call authorized by this section may be held only if:
- 16 (1) the meeting is a special called meeting and
- 17 immediate action is required; and
- 18 (2) the convening at one location of a quorum of the
- 19 governing body of the applicable water district is difficult or
- 20 impossible.
- 21 <u>(d) A meeting held by telephone conference call must</u>
- 22 otherwise comply with the procedures under Sections 551.125(c),
- 23 (d), (e), and (f).
- (e) A meeting held by video conference call is subject to

- 1 the notice requirements applicable to other meetings. In addition,
- 2 <u>a meeting held by video conference call shall:</u>
- 3 (1) be visible and audible to the public at the
- 4 location specified in the notice of the meeting as the location of
- 5 the meeting;
- 6 (2) be recorded by audio and video; and
- 7 (3) have two-way audio and video communications with
- 8 <u>each participant in the meeting during the entire meeting.</u>
- 9 SECTION 2. This Act takes effect immediately if it receives
- 10 a vote of two-thirds of all the members elected to each house, as
- 11 provided by Section 39, Article III, Texas Constitution. If this
- 12 Act does not receive the vote necessary for immediate effect, this
- 13 Act takes effect September 1, 2013.
