- 16 (j) This Act expires September 1, 2023 [<del>2013</del>].
- 17 SECTION 2. (a) It is the intent of the legislature that
- 18 amendments to Chapter 356 (H.B. 1232), Acts of the 81st
- 19 Legislature, Regular Session, 2009, made by this Act and any other
- 20 amendments to that chapter made by another Act of the 83rd
- 21 Legislature, Regular Session, 2013, shall be harmonized, if
- 22 possible, as provided by Subsection (b), Section 311.025,
- 23 Government Code, so that effect may be given to each amendment.
- 24 (b) If an amendment to Chapter 356 (H.B. 1232), Acts of the

- 1 81st Legislature, Regular Session, 2009, made by this Act and an
- 2 amendment to that chapter made by another Act of the 83rd
- 3 Legislature, Regular Session, 2013, are irreconcilable, it is the
- 4 intent of the legislature that the amendment to Chapter 356 (H.B.
- 5 1232), Acts of the 81st Legislature, Regular Session, 2009, made by
- 6 this Act prevail, regardless of the relative effective dates or
- 7 dates of enactment of the irreconcilable amendments.
- 8 SECTION 3. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect on the 91st day after the last day of the
- 13 legislative session.
