This chapter applies only to eligible survivors of the following individuals: 9 10 (1)an individual elected, appointed, or employed as a peace officer by the state or a political subdivision of the state 11 12 under Article 2.12, Code of Criminal Procedure, or other law; 13 (2) a paid probation officer appointed by the director 14 of a community supervision and corrections department who has the 15 duties set out in Section 76.002 and the qualifications set out in Section 76.005, or who was appointed in accordance with prior law; 16 17 (3) a parole officer employed by the Texas Department of Criminal Justice who has the duties set out in Section 508.001 18 and the qualifications set out in Section 508.113 or in prior law; 19 20 (4) a paid jailer; member of an organized police reserve 21 (5) а or 22 auxiliary unit who regularly assists peace officers in enforcing 23 criminal laws; 24 (6) a member of the class of employees of the

No. 396 formally correctional institutions division 1 designated as 2 custodial personnel under Section 615.006 by the Texas Board of Criminal Justice or its predecessor in function; 3 4 (7) a jailer or guard of a county jail who is appointed by the sheriff and who: 5 6 (A) performs security, а custodial, or 7 supervisory function over the admittance, confinement, or discharge of prisoners; and 8 9 (B) is certified by the Commission on Law 10 Enforcement Officer Standards and Education; 11 (8) a juvenile correctional employee of the Texas Juvenile Justice Department [Youth Commission]; 12 13 (9) an employee of the Department of Aging and Disability Services or Department of State Health Services who: 14 15 (A) works at the department's maximum security 16 unit; or 17 (B) performs on-site services for the Texas Department of Criminal Justice; 18 an individual who is employed by the state or a 19 (10)20 political or legal subdivision and is subject to certification by the Texas Commission on Fire Protection; 21 22 (11)an individual employed by the state or а political or legal subdivision whose principal duties are aircraft 23 24 crash and rescue fire fighting; 25 (12) a member of an organized volunteer fire-fighting 26 unit that: renders fire-fighting 27 (A) services without

1 remuneration; and 2 (B) conducts a minimum of two drills each month, each two hours long; 3 4 (13)an individual who: 5 (A) performs emergency medical services or 6 operates an ambulance; 7 (B) is employed by a political subdivision of the state or is an emergency medical services volunteer as defined by 8 Section 773.003, Health and Safety Code; and 9 10 (C) is qualified as an emergency care attendant or at a higher level of training under Section 773.046, 773.047, 11 773.048, 773.049, or 773.0495, Health and Safety Code; 12 13 (14)an individual who is employed or formally designated as a chaplain for: 14 15 (A) an organized volunteer fire-fighting unit or 16 other fire department of this state or of a political subdivision of 17 this state; 18 (B) a law enforcement agency of this state or of a political subdivision of this state; or 19 (C) the Texas Department of Criminal Justice; 20 [or] 21 22 (15)an individual who is employed by the state or a political subdivision of the state and who is considered by the 23 governmental employer to be a trainee for a position otherwise 24 25 described by this section; 26 (16) an individual who is employed by the Department 27 of Public Safety and, as certified by the director, is:

22	SECTION 2. The change in law made by this Act relating to

25	only in relation to a death that occurs on or after the effective

26 date of this Act. Matters regarding eligibility, payment, and 27 benefits under Chapter 615, Government Code, in relation to a death

1 that occurs before the effective date of this Act are governed by 2 the law in effect when the death occurs, and the former law is 3 continued in effect for that purpose.

4 SECTION 3. This Act takes effect September 1, 2013.
