1-15 A BILL TO BE ENTITLED
 1-16 AN ACT

1-17 relating to conforming the eligibility under a major events trust
 1-18 fund of a National Collegiate Athletic Association Division I
 1-19 Football Bowl Subdivision postseason event with the changes to the
 1-20 Bowl Championship Series system.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Subdivision (4), Subsection (a), Section 5A,
 1-23 Chapter 1507 (S.B. 456), Acts of the 76th Legislature, Regular
 1-24 Session, 1999 (Article 5190.14, Vernon's Texas Civil Statutes), is
 1-25 amended to read as follows:

1-26 (4) "Event" means a Super Bowl, a National Collegiate
 1-27 Athletic Association Final Four tournament game, the National
 1-28 Basketball Association All-Star Game, the National Hockey League
 1-29 All-Star Game, the Major League Baseball All-Star Game, a game of
 1-30 the National Collegiate Athletic Association Bowl Championship
 1-31 Series or its successor or a National Collegiate Athletic
 1-32 Association Division I Football Bowl Subdivision postseason
 1-33 playoff or championship game, a World Cup Soccer game, the World
 1-34 Games, a national collegiate championship of an amateur sport
 1-35 sanctioned by the national governing body of the sport that is
 1-36 recognized by the United States Olympic Committee, an Olympic
 1-37 activity, including a Junior or Senior activity, training program,
 1-38 or feeder program sanctioned by the United States Olympic
 1-39 Committee's Community Olympic Development Program, the Breeders'
 1-40 Cup World Championships, a Formula One automobile race, the Academy
 1-41 of Country Music Awards, the National Cutting Horse Association
 1-42 Triple Crown, or a national political convention of the Republican
 1-43 National Committee or the Democratic National Committee. The term
 1-44 includes any activities related to or associated with an event.

1-45 SECTION 2. This Act takes effect immediately if it receives
 1-46 a vote of two-thirds of all the members elected to each house, as
 1-47 provided by Section 39, Article III, Texas Constitution. If this
 1-48 Act does not receive the vote necessary for immediate effect, this
 1-49 Act takes effect September 1, 2013.
