Subdivision 11 Section 663.001, Transportation Code, is amended to read as follows: 12 "All-terrain vehicle" means a motor vehicle that 13 (1)14 is: 15 (A) equipped with a seat or seats [saddle] for 16 the use of: 17 (i) the rider; and 18 (ii) a passenger, if the motor vehicle is designed by the manufacturer to transport a passenger; 19 designed to propel itself with three or four 20 (B) tires in contact with the ground; 21 22 (C) designed by the manufacturer for off-highway use by the operator only; [and] 23 not designed by the manufacturer for farming 24 (D) 25 or lawn care; and (E) not more than 50 inches wide. 26 27 SECTION 3.
