1-25 relating to the remittance dates of certain taxes and fees and the
 1-26 allocation dates of certain state money.

1-27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-28 SECTION 1. The following provisions of the Alcoholic
 1-29 Beverage Code are repealed:

- 1-30 (1) Subsections (c), (d), and (e), Section 34.04;
- 1-31 (2) Subsections (c), (d), and (e), Section 48.04;
- 1-32 (3) Subsections (b), (c), and (d), Section 201.07;
- 1-33 (4) Subsections (c), (d), and (e), Section 201.43; and
- 1-34 (5) Subsections (c), (d), and (e), Section 203.03.

1-35 SECTION 2. Subsection (c), Section 466.355, Government
 1-36 Code, is repealed.

1-37 SECTION 3. The following provisions of the Tax Code are
 1-38 repealed:

- 1-39 (1) Subsections (c), (d), and (e), Section 151.401;
- 1-40 (2) Subsection (b), Section 151.402;
- 1-41 (3) Subsections (a-1), (a-2), (a-3), and (a-4),
 1-42 Section 162.113;
- 1-43 (4) Subsections (a-1), (a-2), (a-3), and (a-4),
 1-44 Section 162.214;
- 1-45 (5) Subsection (b), Section 162.503;
- 1-46 (6) Subsection (b), Section 162.504; and
- 1-47 (7) Subsections (c), (d), and (e), Section 183.023.

1-48 SECTION 4. (a) This Act takes effect immediately if it
 1-49 receives a vote of two-thirds of all the members elected to each
 1-50 house, as provided by Section 39, Article III, Texas Constitution.
 1-51 Except as provided by Subsection (b) of this section, if this Act
 1-52 does not receive the vote necessary for immediate effect, this Act
 1-53 has no effect.

1-54 (b) If this Act does not receive the vote necessary for
 1-55 immediate effect, Section 2 of this Act takes effect September 1,
 1-56 2013.
