amendment; [and] 1 2 (4) each primary election and runoff primary election 3 if: 4 (A) the county chair or county executive 5 committee of each political party participating in a joint primary 6 election under Section 172.126 agrees to the use of countywide 7 polling places; or 8 (B) the county chair or county executive 9 committee of each political party required to nominate candidates 10 by primary election agrees to use the same countywide polling 11 places; and (5) each election of a political subdivision located 12 in the county that is held jointly with an election described by 13 Subdivision (1), (2), (3), or (4) [(3)]. 14 15 SECTION 3. This Act takes effect September 1, 2013.
