Section 1414(a), as amended, receives written consent for the evaluation, signed by the student's parent or legal guardian, 16 17 except that if a student has been absent from school during that period on three or more days, that period must be extended by a 18 number of school days equal to the number of school days during that 19 period on which the student has been absent; or 20 21 (2) for students under five years of age by September 1 22 of the school year and not enrolled in public school and for

students enrolled in a private or home school setting, not later

than the 45th school day following the date on which the school

- 3 (a-1) If a school district receives written consent signed
- 4 by a student's parent or legal guardian for a full individual and
- 5 initial evaluation of a student at least 35 but less than 45 school

- SECTION 3. This Act takes effect September 1, 2013.
