| 4 | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: |
| 5 | SECTION 1. Section 535.055, Government Code, is amended to |
| 6 | read as follows: |
| 7 | Sec. 535.055. TEXAS NONPROFIT COUNCIL [TASK FORCE ON |
| 8 | IMPROVING RELATIONS WITH NONPROFITS]. (a) The Texas Nonprofit |
| 9 | Council [interagency coordinating group task force] is established |
| 10 | to help direct the interagency coordinating group in carrying out |
| 11 | the group's duties under this section. The commission shall |
| 12 | provide administrative support to the $\underline{\text{council}}$ [$\underline{\text{task force}}$]. |
| 13 | (b) The executive commissioner, in consultation with the |
| 14 | presiding officer of the interagency coordinating group, shall |
| 15 | appoint as members of the council two representatives [task force |
| 16 | one representative] from each of the following groups and entities: |
| 17 | (1) [a] statewide nonprofit <u>organizations</u> |
| 18 | [organization]; |
| 19 | (2) local governments; |
| 20 | (3) faith-based groups; |
| 21 | (4) community-based groups; |
| 22 | (5) consultants to nonprofit corporations; and |
| 23 | (6) [experts in grant writing; and |
| 24 | [(7) a] statewide <u>associations</u> [association] of |

- 2 (c) The council [In addition to the interagency
- 3 coordinating group's other duties, the interagency coordinating
- 4 group], in coordination with the interagency coordinating group
- 5 [task force], shall:
- 6 (1) make recommendations [develop and implement a
- $7 \text{ } \frac{\text{plan}}{\text{plan}}$] for improving contracting relationships between state
- 8 agencies and faith- and community-based organizations;
- 9 (2) develop best practices for cooperating and
- 10 collaborating with faith- and community-based organizations;
- 11 (3) identify and address duplication of services
- 12 provided by the state and faith- and community-based organizations;
- 13 and
- 14 (4) identify and address gaps in state services that
- 15 faith- and community-based organizations could fill.
- 16 <u>(c-1)</u> The council shall elect a chair or chairs and
- 17 secretary from among its members and shall assist the executive
- 18 commissioner in identifying individuals to fill vacant council
- 19 positions that arise.
- 20 <u>(c-2)</u> Council members serve three-year terms. The terms
- 21 expire on October 1 of every third year. A council member shall
- 22 serve a maximum of two consecutive terms.
- 23 (d) The council [task force] shall prepare a biennial report
- 24 detailing the council's work, including [describing actions taken
- 25 or not taken by the interagency coordinating group under this
- 26 section and include] in the report any recommendations relating to
- 27 legislation necessary to address an issue identified [by the group]

- 1 under this section. The council [task force] shall present the
- 2 report to the House Committee on Human Services or its successor,
- 3 the House Committee on Public Health or its successor, and the
- 4 Senate Health and Human Services Committee or its successor not
- 5 later than <u>December 1 of each even-numbered year</u> [September 1,
- $6 \frac{2012}{1}$.
- 7 (e) Chapter 2110 does not apply to the Texas Nonprofit
- 8 Council.
- 9 <u>(f) The council is subject to Chapter 325 (Texas Sunset</u>
- 10 Act), but is not abolished under that chapter. The council shall be
- 11 reviewed during the period in which state agencies abolished in
- 12 2019 and every 12th year after 2019 are reviewed. [This section
- 13 expires September 1, 2013.
- SECTION 2. Not later than October 1, 2013, and by October 1
- 15 every three years thereafter, the executive commissioner of the
- 16 Health and Human Services Commission shall appoint members to the
- 17 Texas Nonprofit Council in accordance with Section 535.055,
- 18 Government Code, as amended by this Act.
- 19 SECTION 3. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect August 31, 2013.
