S.B. No. 1032

A BILL TO BE ENTITLED

AN ACT

1
2 relating to addressing disproportionality and disparities in the
3 education, juvenile justice, child welfare, health, and mental
4 health systems, the continuation and operation of the Interagency
5 Council for Addressing Disproportionality, and the duties of the
6 Center for Elimination of Disproportionality and Disparities.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

8 SECTION 1. Chapter 107A, Health and Safety Code, is amended
9 by adding Sections 107A.0021 and 107A.0022 and amending Section
10 107A.003 to read as follows:

11 Sec. 107A.0021. DUTIES OF CENTER; REPORT. (a) The center
12 shall:

13 (1) identify the social determinants and health
14 conditions in most need of high-impact response to address
15 disproportionality and disparities across health and human
16 services agencies;

17 (2) monitor the implementation of plans to address
18 health disparities across health and human services agencies;

19 (3) assist the Health and Human Services Commission
20 and any other relevant health and human services, education,
21 juvenile justice, child welfare, and mental health agencies in
22 developing cross-systems performance measures aligned with the
23 components of the Texas model for addressing disproportionality and
24 disparities in the education, juvenile justice, child welfare,

1 health, and mental health systems adopted under Section 2.003(b),
2 Human Resources Code; and

3 (4) implement the Texas model for addressing
4 disproportionality and disparities in the education, juvenile
5 justice, child welfare, health, and mental health systems adopted
6 under Section 2.003(b), Human Resources Code.

7 (b) Not later than July 1 of each year, the center shall
8 submit a report to the executive commissioner of the Health and
9 Human Services Commission detailing the center's findings and
10 activities under Subsections (a)(1) and (2).

11 Sec. 107A.0022. CULTURAL AWARENESS. The center shall:

12 (1) advise each health and human services, education,
13 juvenile justice, child welfare, and mental health agency on the
14 implementation and delivery of cultural competency training to all
15 service delivery staff, including persons providing service
16 delivery under a single source continuum contract; and

17 (2) develop collaborative partnerships with community
18 groups, agencies, faith-based organizations, and other community
19 organizations to support the delivery of culturally competent
20 services to children and families of every race and ethnicity.

21 Sec. 107A.003. FUNDING. The Health and Human Services
22 Commission may distribute to the center unobligated and unexpended
23 appropriations to be used to carry out its powers and perform its
24 duties.

25 SECTION 2. Section 2.002, Human Resources Code, is amended
26 by amending Subsection (a) and adding Subsection (f) to read as
27 follows:

1 (a) The council consists of:

2 (1) one representative from each of the following
3 agencies appointed by the executive director, director, or
4 commissioner of each agency:

5 (A) the Texas Education Agency;

6 (B) the Center for Elimination of
7 Disproportionality and Disparities within the Health and Human
8 Services Commission;

9 (C) the Department of Assistive and
10 Rehabilitative Services;

11 (D) the Department of Aging and Disability
12 Services;

13 (E) the Department of State Health Services;

14 (F) the Department of Family and Protective
15 Services;

16 (G) the Texas Juvenile Justice Department [~~Youth~~
17 ~~Commission,~~

18 [~~(H) the Texas Juvenile Probation Commission~~];

19 (H) [~~(I)~~] the Health and Human Services
20 Commission; and

21 (I) [~~(J)~~] the Office of Court Administration of
22 the Texas Judicial System;

23 (2) one representative of the office of the attorney
24 general appointed by the attorney general;

25 (3) one representative of the Permanent Judicial
26 Commission for Children, Youth and Families appointed by the chair
27 of the commission;

1 (4) four representatives [~~one representative~~] of the
2 community appointed by the executive commissioner of the Health and
3 Human Services Commission, including:

4 (A) one person who works with a community-based
5 organization that works with child welfare, juvenile justice,
6 education, or children's mental health issues;

7 (B) one person who is a former foster care youth;
8 and

9 (C) two persons who are current or former
10 recipients of services provided by the child welfare, juvenile
11 justice, education, or children's mental health systems [~~appointed~~
12 ~~by the executive commissioner of the Health and Human Services~~
13 ~~Commission~~];

14 (5) one representative of a faith-based community
15 organization appointed by the executive commissioner of the Health
16 and Human Services Commission;

17 (6) one representative of the criminal justice
18 division of the governor's office appointed by the governor;

19 (7) [~~one person who is a former foster care youth~~
20 ~~appointed by the executive commissioner of the Health and Human~~
21 ~~Services Commission, and]~~

22 [~~(8)~~] two representatives of the medical community
23 appointed by the executive commissioner of the Health and Human
24 Services Commission; and

25 (8) one representative of the business community
26 appointed by the executive commissioner of the Health and Human
27 Services Commission.

1 (f) A member of the council appointed under Subsection
2 (a)(4), (5), (7), or (8) may not serve on the council for more than
3 two years.

4 SECTION 3. Sections 2.003, 2.005, and 2.008, Human
5 Resources Code, are amended to read as follows:

6 Sec. 2.003. COUNCIL DUTIES; TEXAS MODEL FOR ADDRESSING
7 DISPROPORTIONALITY AND DISPARITIES [~~IN PREPARATION OF REPORT~~]. (a)

8 The council's duties include:

9 (1) reviewing the delivery of public and private child
10 welfare, juvenile justice, and mental health services to evaluate
11 the disproportionate rates of use of the services by children who
12 are members of a racial or ethnic minority group;

13 (2) reviewing the delivery of public education
14 services to determine which of those services are delivered
15 disproportionately to children who are members of a racial or
16 ethnic minority group;

17 (3) reviewing federal, state, and local funds
18 appropriated to address the disproportionate use of children's
19 services by children who are members of a racial or ethnic minority
20 group;

21 (4) reviewing current best practice standards
22 addressing the disproportionate use of children's services by
23 children who are members of a racial or ethnic minority group;

24 (5) examining the qualifications and training of
25 children's service providers and making recommendations for
26 training curriculum and other necessary changes;

27 (6) recommending methods to improve use of available

1 public and private funds to address the disproportionate use of
2 children's services by children who are members of a racial or
3 ethnic minority group;

4 (7) providing information concerning identified unmet
5 children's service needs and providing recommendations concerning
6 the development of resources to meet the identified needs;

7 (8) examining outcomes for children who are members of
8 a racial or ethnic minority group who have exited or will exit the
9 public and private child welfare, juvenile justice, mental health,
10 and education systems; and

11 (9) recommending administrative and legislative
12 actions related to appropriate programs and services to reduce and
13 eliminate disparities in the systems and improve the long-term
14 outcomes for children who are members of a racial or ethnic minority
15 group who are served by the systems[~~, and~~

16 [~~(10) preparing a report consisting of the council's~~
17 ~~findings and recommendations and the presentation of an~~
18 ~~implementation plan to address disproportionate representation of~~
19 ~~children who are members of a racial or ethnic minority group in the~~
20 ~~use of children's services].~~

21 (b) Based on its research and findings, the council shall
22 develop and adopt a Texas model for addressing disproportionality
23 and disparities in the education, juvenile justice, child welfare,
24 health, and mental health systems to be implemented across the
25 relevant state agencies.

26 Sec. 2.005. COUNCIL REPORT. Not later than December 1,
27 2014 [~~2012~~], the council shall prepare and submit to the lieutenant

1 governor, the speaker of the house of representatives, and the
2 legislature a report containing:

3 (1) the status of the implementation of the Texas
4 model for addressing disproportionality and disparities in the
5 education, juvenile justice, child welfare, health, and mental
6 health systems adopted under Section 2.003(b); [~~council's findings~~
7 ~~and recommendations for addressing the disproportionate~~
8 ~~representation of children who are members of a racial or ethnic~~
9 ~~minority group in the use of children's services]~~ and

10 (2) the council's recommendation as to whether to
11 continue the council.

12 Sec. 2.008. EXPIRATION OF CHAPTER. This chapter expires
13 December 1, 2015 [~~2013~~].

14 SECTION 4. Section 2.004(c), Human Resources Code, is
15 repealed.

16 SECTION 5. The Center for Elimination of Disproportionality
17 and Disparities within the Health and Human Services Commission is
18 not required to submit the initial report required under Section
19 107A.0021(b), Health and Safety Code, as added by this Act, before
20 July 1, 2014.

21 SECTION 6. This Act takes effect immediately if it receives
22 a vote of two-thirds of all the members elected to each house, as
23 provided by Section 39, Article III, Texas Constitution. If this
24 Act does not receive the vote necessary for immediate effect, this
25 Act takes effect September 1, 2013.
