"Individual's legally authorized representative" 3 (2) 4 has the meaning assigned by Section 1001.080(a). 5 The department may develop informational materials (b) regarding health care insurance coverage and subsidies available 6 7 under a health insurance exchange. (c) The department shall provide the informational 8 9 materials regarding health care insurance coverage and subsidies available under a health insurance exchange to an individual or the 10 11 individual's legally authorized representative who: 12 (1) applies to receive health or mental health 13 benefits, services, or assistance described in Section 1001.080(b); and 14 15 (2) has an income above 100 percent of the federal 16 poverty level. 17 (d) The executive commissioner shall adopt rules necessary to implement this section. 18 SECTION 2. As soon as practicable after the effective date 19 20 of this Act, the Department of State Health Services shall prescribe the form required by Section 1001.080, Health and Safety 21 22 Code, as added by this Act.

SECTION 3. As soon as possible after the effective date of 23 24 this Act, the Health and Human Services Commission shall apply for 25 any waiver or other authorization necessary to implement this Act. The commission may delay implementing this Act until the waiver or 26 27 authorization is granted.

1 SECTION 4. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2013.
