## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation, administration, powers, duties,
3	functions, operations, and financing of the Crystal Clear Special
4	Utility District; providing authority to issue bonds; granting a
5	limited power of eminent domain.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle C, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 7206 to read as follows:
9	CHAPTER 7206. CRYSTAL CLEAR SPECIAL UTILITY DISTRICT
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 7206.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Corporation" means the Crystal Clear Water Supply
14	Corporation.
15	(3) "Director" means a board member.
16	(4) "District" means the Crystal Clear Special Utility
17	District.
18	Sec. 7206.002. NATURE OF DISTRICT. The district is a
19	special utility district in Comal, Guadalupe, and Hays Counties
20	created under and essential to accomplish the purposes of Section
21	59, Article XVI, Texas Constitution. The district is created to
22	serve a public use and benefit.
23	Sec. 7206.003. CONFIRMATION ELECTION REQUIRED. If the
24	creation of the district is not confirmed at a confirmation and

- 1 initial directors' election held before September 1, 2016:
- 2 (1) the district is dissolved on September 1, 2016,
- 3 except that the district shall:
- 4 (A) pay any debts incurred;
- 5 (B) transfer to Comal, Guadalupe, or Hays County,
- 6 as appropriate, any assets of the district that remain after the
- 7 payment of debts; and
- 8 (C) maintain the organization of the district
- 9 until all debts are paid and remaining assets are transferred; and
- 10 (2) this chapter expires September 1, 2017.
- Sec. 7206.004. APPLICABILITY OF OTHER LAW. Except as
- 12 otherwise provided by this chapter, Chapters 49 and 65, Water Code,
- 13 apply to the district.
- 14 Sec. 7206.005. INITIAL DISTRICT TERRITORY. (a) The
- 15 district is initially composed of the territory described by
- 16 Section 2 of the Act creating this chapter.
- 17 (b) The boundaries and field notes contained in Section 2 of
- 18 the Act creating this chapter form a closure. A mistake made in the
- 19 field notes or in copying the field notes in the legislative process
- 20 does not affect:
- 21 (1) the organization, existence, or validity of the
- 22 <u>district;</u>
- 23 (2) the right of the district to issue any type of
- 24 bond, including a refunding bond, for a purpose for which the
- 25 district is created or to pay the principal of and interest on a
- 26 bond; or
- 27 (3) the legality or operation of the district or the

         (e) As soon as practicable after all the temporary directors
   have qualified under Section 49.055, Water Code, the temporary

- 2 Sec. 7206.022. CONFIRMATION AND INITIAL DIRECTORS'
- 3 ELECTION. (a) Before September 1, 2016, the temporary directors
- 4 shall hold an election to confirm the creation of the district and
- 5 to elect seven initial directors in accordance with Chapters 49 and
- 6 65, Water Code.
- 7 (b) The temporary board of directors shall determine the
- 8 method for determining the initial term of each person on the
- 9 initial board of directors. The terms must be clearly stated on the
- 10 ballot for the confirmation and directors' election.
- 11 (c) Section 41.001(a), Election Code, does not apply to a
- 12 <u>confirmation and directors' election held as provided</u> by this
- 13 section.
- 14 (d) The initial directors shall continue to serve until the
- 15 district directors elected at the first regularly scheduled
- 16 election of directors under Section 7206.052 qualify for office.
- Sec. 7206.023. TRANSFER OF ASSETS; DISSOLUTION. (a) If
- 18 the creation of the district is confirmed under Section 7206.022,
- 19 the corporation shall transfer the assets, debts, and contractual
- 20 rights and obligations of the corporation to the district.
- 21 (b) Not later than the 30th day after the date of the
- 22 transfer under Subsection (a), the board of directors of the
- 23 <u>corporation</u> shall commence dissolution proceedings of the
- 24 corporation.
- 25 (c) On dissolution of the corporation, Certificate of
- 26 Convenience and Necessity No. 10297 is considered to be held by the
- 27 district.

- 1 (d) The board of directors of the corporation shall notify
- 2 the Texas Commission on Environmental Quality of the dissolution of
- 3 the corporation and of the transfer of Certificate of Convenience
- 4 and Necessity No. 10297 to the district.
- 5 (e) On receipt of notice under Subsection (d), the Texas
- 6 Commission on Environmental Quality shall note in its records that
- 7 Certificate of Convenience and Necessity No. 10297 is held by the
- 8 district and shall reissue the certificate in the name of the
- 9 district without further application, notice, or hearing. A
- 10 person, party, or entity does not have any right of protest,
- 11 objection, or administrative review of the transfer prescribed by
- 12 this section.
- Sec. 7206.024. EXPIRATION OF SUBCHAPTER. This subchapter
- 14 expires September 1, 2017.
- 15 SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 7206.051. DIRECTORS. (a) The district shall be
- 17 governed by a board of not fewer than 5 and not more than 11
- 18 directors, elected in accordance with Section 65.101, Water Code.
- 19 (b) The directors of the district serve staggered
- 20 three-year terms.
- Sec. 7206.052. ELECTION OF DIRECTORS. After the district
- 22 <u>is confirmed under Section 7206.022</u>, the district shall hold an
- 23 <u>election on the uniform election date in November of each year to</u>
- 24 elect the appropriate number of directors.
- 25 SUBCHAPTER C. POWERS AND DUTIES
- Sec. 7206.101. GENERAL POWERS. Except as otherwise
- 27 provided by this chapter, the district has all of the rights,

- 1 powers, privileges, authority, functions, and duties provided by
- 2 the general law of this state, including Chapters 49 and 65, Water
- 3 Code, applicable to special utility districts created under Section
- 4 59, Article XVI, Texas Constitution.
- 5 Sec. 7206.102. WATER SERVICE IMPACT FEE. (a) The district
- 6 may charge a water service impact fee that is not greater than the
- 7 capital recovery fee charged by the corporation on December 31,
- 8 2012, under the corporation's tariff.
- 9 (b) Chapter 395, Local Government Code, does not apply to an
- 10 initial water service impact fee set under Subsection (a).
- 11 (c) The district may increase the water service impact fee
- 12 authorized under Subsection (a) only as provided by Chapter 395,
- 13 Local Government Code, as approved by the Texas Commission on
- 14 Environmental Quality, or as otherwise provided by law.
- Sec. 7206.103. EMINENT DOMAIN. (a) Except as provided by
- 16 Subsection (b), the district has all the power and authority of a
- 17 special utility district under Chapters 49 and 65, Water Code, to
- 18 acquire by condemnation any land, easement, or other property
- 19 located inside or outside the boundaries of the district for any
- 20 district project or purpose.
- 21 (b) The district may not exercise the power of eminent
- 22 domain to condemn land, easements, or other property located
- 23 outside the boundaries of the district for sanitary sewer purposes.
- Sec. 7206.104. SERVICES TO BE PROVIDED BY DISTRICT OR CITY
- 25 OF NEW BRAUNFELS. (a) A structure constructed by the district in
- 26 the corporate limits or extraterritorial jurisdiction of the City
- 27 of New Braunfels must comply with any applicable codes and

- 1 ordinances of the city.
- 2 (b) The district may enter into an interlocal contract with
- 3 the City of New Braunfels to provide governmental services,
- 4 including drainage, solid waste, or fire protection services.
- 5 (c) The district may not provide solid waste collection
- 6 services in the corporate limits of the City of New Braunfels unless
- 7 the governing body of the city consents by resolution or ordinance.
- 8 (d) The district may not provide fire protection services in
- 9 the corporate limits or extraterritorial jurisdiction of the City
- 10 of New Braunfels unless the governing body of the city consents by
- 11 resolution or ordinance.
- 12 SECTION 2. The Crystal Clear Special Utility District
- 13 initially includes all the territory contained in the following
- 14 area:
- BEING that portion of Comal, Guadalupe, and Hays Counties,
- 16 Texas, which has a boundary more particularly described as follows:

- 7 THENCE with the City of Seguin CCN #10698 line, in a northerly
- 8 direction, to a point at its intersection of the Springs Hill WSC
- 9 CCN #10666 boundary;
- 10 THENCE with the boundary of Springs Hill WSC CCN #10666 in a
- 11 northerly direction to the City Limit Line of Seguin, Texas;
- 12 THENCE with the City Limit Line of Seguin, Texas, in a northerly,
- 13 then westerly direction, to its intersection with the eastern
- 14 boundary of Springs Hill WSC CCN #10666;
- 15 THENCE meandering with the boundary line of Springs Hill WSC CCN
- 16 #10666 in a northwesterly direction to a point on the east boundary
- 17 line of the 810.54 acre tract of land described in the deed to
- 18 Normandy Terrace, Inc. recorded in the Guadalupe County Deed
- 19 Records;
- 20 THENCE with the eastern boundary of the 810.54 acre Normandy
- 21 Terrace Inc. tract in a northern direction to its northeast corner;
- 22 THENCE with the northern boundary of the 810.54 acre Normandy
- 23 Terrace Inc. tract in a westerly direction to the centerline of
- 24 Guadalupe County Road 140 (Schwarzlose Rd.);
- 25 THENCE with the centerline of Guadalupe County Road 140
- 26 (Schwarzlose Rd.), in a southerly direction to its intersection
- 27 with the boundary line of New Braunfels Utility CCN #10677;

- 23 introduce this Act, setting forth the general substance of this
