## A BILL TO BE ENTITLED

- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 54.341, Education Code, is amended by
- 5 amending Subsections (a-2), (b), (d), (h), (i), (k), (k-1), (1),
- 6 (m), and (n) and adding Subsections (a-4) and (o) to read as
- 7 follows:
- 8 (a-2) The exemptions provided for in Subsection (a) also
- 9 apply to the spouse of:
- 10 (1) a member of the armed forces of the United States:
- 11 (A) who was killed in action;
- 12 (B) who died while in service;
- 13 (C) who is missing in action;
- 14 (D) whose death is documented to be directly
- 15 caused by illness or injury connected with service in the armed
- 16 forces of the United States; or
- 17 (E) who became totally <u>and permanently</u> disabled
- 18 or meets the eligibility requirements for individual
- 19 <u>unemployability</u> [for purposes of employability] according to the
- 20 disability ratings of the Department of Veterans Affairs as a
- 21 result of a service-related injury; or
- 22 (2) a member of the Texas National Guard or the Texas
- 23 Air National Guard who:
- 24 (A) was killed since January 1, 1946, while on

- 1 active duty either in the service of this state or the United
- 2 States; or
- 3 (B) is totally <u>and permanently</u> disabled <u>or meets</u>
- 4 the eligibility requirements for individual unemployability [for
- 5 purposes of employability according to the disability ratings of
- 6 the Department of Veterans Affairs, regardless of whether the
- 7 member is eligible to receive disability benefits from the
- 8 department, as a result of a service-related injury suffered since
- 9 January 1, 1946, while on active duty either in the service of this
- 10 state or the United States.
- 11 (a-4) A person who before the 2014-2015 academic year
- 12 received an exemption under this section continues to be eligible
- 13 for the exemption provided by this section as this section existed
- 14 on January 1, 2013.
- 15 (b) The exemptions provided for in Subsection (a) also apply
- 16 to:
- 17 (1) the children of members of the armed forces of the
- 18 United States:
- 19 (A) who are or were killed in action;
- 20 (B) who die or died while in service;
- 21 (C) who are missing in action;
- (D) whose death is documented to be directly
- 23 caused by illness or injury connected with service in the armed
- 24 forces of the United States; or
- 25 (E) who became totally <u>and permanently</u> disabled
- 26 or meet the eligibility requirements for individual
- 27 unemployability [for purposes of employability] according to the

- 1 disability ratings of the Department of Veterans Affairs as a
- 2 result of a service-related injury; and
- 3 (2) the children of members of the Texas National
- 4 Guard and the Texas Air National Guard who:
- 5 (A) were killed since January 1, 1946, while on
- 6 active duty either in the service of their state or the United
- 7 States; or
- 8 (B) are totally and permanently disabled or meet
- 9 the eligibility requirements for individual unemployability [for
- 10 purposes of employability according to the disability ratings of
- 11 the Department of Veterans Affairs, regardless of whether the
- 12 members are eligible to receive disability benefits from the
- 13 department, as a result of a service-related injury suffered since
- 14 January 1, 1946, while on active duty either in the service of this
- 15 state or the United States.
- 16 (d) The governing board of each institution of higher
- 17 education granting an exemption under this section shall require
- 18 each applicant claiming the exemption to submit to the institution,
- 19 in the form and manner prescribed by the Texas Veterans Commission
- 20 for purposes of this section under Section 434.0079(b), Government
- 21 <u>Code</u>, an application for the exemption and <u>necessary</u> [satisfactory]
- 22 evidence that the applicant qualifies for the exemption not later
- 23 than the official day of record for the semester or term to which
- 24 the exemption applies on which the institution must determine the
- 25 enrollment that is reported to the Texas Higher Education
- 26 Coordinating Board or on another day, not later than the end of the
- 27 semester, as determined by the governing board [one year after the

- 1 earlier of the date the institution:
- 2 [(1) provides written notice to the applicant of the
- 3 applicant's eligibility for the exemption; or
- 4 [(2) receives a written acknowledgement from the
- 5 applicant evidencing the applicant's awareness of the applicant's
- 6 eligibility for the exemption].
- 7 (h) The governing board of each institution of higher
- 8 education shall electronically report to the Texas Veterans
- 9 Commission [Higher Education Coordinating Board] the information
- 10 required by Section <u>434.00791</u>, <u>Government Code</u>, [<del>61.0516</del>] relating
- 11 to each individual receiving an exemption from fees and charges
- 12 under Subsection (a), (a-2), or (b). The institution shall report
- 13 the information for the preceding fiscal year not later than
- 14 December 31 of each year [for the fall semester, May 31 of each year
- 15 for the spring semester, and September 30 of each year for the
- 16 summer session].
- 17 (i) The <u>Texas Veterans Commission</u> [<del>Texas Higher Education</del>
- 18 Coordinating Board] may adopt rules to provide for the efficient
- 19 and uniform application of this section. <u>In developing rules under</u>
- 20 this subsection, the commission shall consult with the Texas Higher
- 21 Education Coordinating Board and institutions of higher education.
- 22 (k) The Texas <u>Veterans Commission</u> [<u>Higher Education</u>
- 23 Coordinating Board] by rule shall prescribe procedures to allow:
- 24 (1) a person who becomes eligible for an exemption
- 25 provided by Subsection (a) to waive the person's right to any unused
- 26 portion of the [maximum] number of cumulative credit hours for
- 27 which the person could receive the exemption and assign the

- 1 exemption for the unused portion of those credit hours to a child of
- 2 the person; and
- 3 (2) following the death of a person who becomes
- 4 eligible for an exemption provided by Subsection (a), the
- 5 assignment of the exemption for the unused portion of the credit
- 6 hours to a child of the person, to be made by the person's spouse or
- 7 by the conservator, quardian, custodian, or other legally
- 8 designated caretaker of the child, if the child does not otherwise
- 9 qualify for an exemption under Subsection (b).
- 10 (k-1) The procedures under Subsection (k) must provide:
- 11 (1) the manner in which a person may waive the
- 12 exemption;
- 13 (2) the manner in which a child may be designated to
- 14 receive the exemption;
- 15 (3) a procedure permitting the designation of a
- 16 different child to receive the exemption if the child previously
- 17 designated to receive the exemption did not use the exemption under
- 18 this section for all of the assigned portion of credit hours; [and]
- 19 (4) a method of documentation to enable institutions
- 20 of higher education to determine the eligibility of the designated
- 21 child to receive the exemption; and
- (5) a procedure permitting a person who waived the
- 23 <u>exemption and designated a child to receive the exemption to revoke</u>
- 24 that designation as to any unused portion of the assigned credit
- 25 hours.
- 26 (1) To be eligible to receive an exemption under Subsection
- 27 (k), the child must:

- 1 (1) be a student who is classified as a resident under
- 2 Subchapter B when the child enrolls in an institution of higher
- 3 education; [and]
- 4 (2) make satisfactory academic progress in a degree,
- 5 certificate, or continuing education program as determined by the
- 6 institution at which the child is enrolled in accordance with the
- 7 policy of the institution's financial aid department, except that
- 8 the institution may not require the child to enroll in a minimum
- 9 course load; and
- 10 (3) be 25 years of age or younger on the first day of
- 11 the semester or other academic term for which the exemption is
- 12 claimed.
- 13 (m) For purposes of this section, a person is the child of
- 14 another person if [the person is 25 years of age or younger on the
- 15 first day of the semester or other academic term for which the
- 16 exemption is claimed and]:
- 17 (1) the person is the stepchild or the biological or
- 18 adopted child of the other person; or
- 19 (2) the other person claimed the person as a dependent
- 20 on a federal income tax return filed for the preceding year or will
- 21 claim the person as a dependent on a federal income tax return for
- 22 the current year.
- 23 (n) The Texas <u>Veterans Commission</u> [<u>Higher Education</u>
- 24 Coordinating Board] by rule shall prescribe procedures by which a
- 25 child assigned an exemption under Subsection (k) who suffered from
- 26 a severe illness or other debilitating condition that affected the
- 27 child's ability to use the exemption before reaching the age

- 1 described by Subsection (1)(3) [(m)] may be granted additional time
- 2 to use the exemption corresponding to the time the child was unable
- 3 to use the exemption because of the illness or condition.
- 4 (o) The Texas Higher Education Coordinating Board and the
- 5 Texas Veterans Commission shall coordinate to provide each
- 6 respective agency with any information required to ensure the
- 7 proper administration of this section and the proper execution of
- 8 each agency's statutory responsibilities concerning this section.
- 9 SECTION 2. Subchapter D, Chapter 54, Education Code, is
- 10 amended by adding Section 54.3411 to read as follows:
- Sec. 54.3411. PERMANENT FUND SUPPORTING MILITARY AND
- 12 VETERANS EXEMPTIONS. (a) In this section, "trust company" means
- 13 the Texas Treasury Safekeeping Trust Company.
- 14 (b) The permanent fund supporting military and veterans
- 15 exemptions is a special fund in the treasury outside the general
- 16 revenue fund. The fund is composed of:
- 17 (1) money transferred or appropriated to the fund by
- 18 the legislature;
- 19 (2) gifts and grants contributed to the fund; and
- 20 (3) the returns received from investment of money in
- 21 the fund.
- (c) The trust company shall administer the fund. The trust
- 23 company shall determine the amount available for distribution from
- 24 the fund, determined in accordance with a distribution policy that
- 25 <u>is adopted by the comptroller and designed to preserve the</u>
- 26 purchasing power of the fund's assets and to provide a stable and
- 27 predictable stream of annual distributions. Expenses of managing

- 1 the fund's assets shall be paid from the fund. Except as provided by
- 2 this section, money in the fund may not be used for any purpose.
- 3 Sections 403.095 and 404.071, Government Code, do not apply to the
- 4 fund.
- 5 (d) In managing the assets of the fund, through procedures
- 6 and subject to restrictions the trust company considers
- 7 appropriate, the trust company may acquire, exchange, sell,
- 8 supervise, manage, or retain any kind of investment that a prudent
- 9 investor, exercising reasonable care, skill, and caution, would
- 10 acquire or retain in light of the purposes, terms, distribution
- 11 requirements, and other circumstances of the fund then prevailing,
- 12 taking into consideration the investment of all the assets of the
- 13 fund rather than a single investment.
- 14 (e) The amount available for distribution from the fund may
- 15 be appropriated only to offset the cost to institutions of higher
- 16 <u>education of the exemptions required by Section 54.341. The amount</u>
- 17 appropriated shall be distributed to eligible institutions in
- 18 proportion to each institution's respective share of the aggregate
- 19 cost to all institutions of the exemptions required by Section
- 20 54.341, as determined by the Legislative Budget Board. The amount
- 21 appropriated shall be distributed annually to each eligible
- 22 institution of higher education.
- 23 (f) The governing board of an institution of higher
- 24 education entitled to receive money under this section may solicit
- 25 and accept gifts and grants to the fund. A gift or grant to the fund
- 26 must be distributed and appropriated for the purposes of the fund,
- 27 subject to any limitation or requirement placed on the gift or grant

- 1 by the donor or granting entity.
- 2 SECTION 3. Subchapter A, Chapter 434, Government Code, is
- 3 amended by adding Section 434.0079 to read as follows:
- 4 Sec. 434.0079. DUTIES REGARDING CERTAIN TUITION AND FEE
- 5 EXEMPTIONS FOR VETERANS AND FAMILY MEMBERS. (a) The commission,
- 6 through its veteran education program, shall assist veterans and
- 7 their family members in claiming and qualifying for exemptions from
- 8 the payment of tuition and fees at institutions of higher education
- 9 under Section 54.341, Education Code.
- 10 (b) The commission shall establish the application and
- 11 necessary evidence requirements for a person to claim an exemption
- 12 under Section 54.341, Education Code, at an institution of higher
- 13 education.
- 14 (c) The commission shall adopt rules governing the
- 15 coordination of federal and state benefits of a person eligible to
- 16 receive an exemption under Section 54.341(k), Education Code,
- 17 including rules governing:
- 18 (1) the total number of credit hours assigned under
- 19 that section that a person may apply to an individual degree or
- 20 certificate program, consistent with the standards of the
- 21 appropriate recognized regional accrediting agency; and
- 22 (2) the application of the assigned exemption to
- 23 credit hours for which the institution of higher education does not
- 24 receive state funding.
- 25 SECTION 4. Section 61.0516, Education Code, is transferred
- 26 to Subchapter A, Chapter 434, Government Code, redesignated as
- 27 Section 434.00791, Government Code, and amended to read as follows:

- 1 Sec. 434.00791 [61.0516]. ELECTRONIC SYSTEM TO MONITOR
- 2 TUITION EXEMPTIONS FOR VETERANS AND FAMILY MEMBERS [DEPENDENTS].
- 3 (a) In this section, "institution of higher education" has the
- 4 meaning assigned by Section 61.003, Education Code.
- 5 (b) The commission [board] shall ensure [develop] a system
- 6 to electronically monitor the use of tuition and fee exemptions at
- 7 <u>institutions of higher education</u> under Section 54.341, Education
- 8 Code, is developed. The system must allow the commission [board] to
- 9 electronically receive, for each semester, the following
- 10 information from institutions of higher education:
- 11 (1) the name of the institution;
- 12 (2) the name, identification number, and date of birth
- 13 of each individual attending the institution and receiving benefits
- 14 for the semester under Section 54.341, Education Code;
- 15 (3) for each individual receiving benefits, the number
- 16 of credit hours for which the individual received an exemption for
- 17 the semester;
- 18 (4) for each individual receiving benefits at the
- 19 institution during the semester, the total cumulative number of
- 20 credit hours for which the individual has received an exemption at
- 21 the institution; and

- 6 SECTION 6. Subdivision (4), Subsection (b), Section 9.01,
