S.B. No. 1169

A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to water conservation.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Chapter 10, Water Code, is amended by adding
- 5 Section 10.0021 to read as follows:
- 6 Sec. 10.0021. SUNSET PROVISION. The Water Conservation
- 7 Advisory Council is subject to Chapter 325, Government Code (Texas
- 8 Sunset Act). Unless continued in existence as provided by that
- 9 chapter, the council is abolished and this chapter expires
- 10 September 1, 2023.
- 11 SECTION 2. Section 10.011, Water Code, is amended to read as
- 12 follows:
- Sec. 10.011. REPORT. Not later than December 1 of each
- 14 even-numbered year, the council shall submit to the governor,
- 15 lieutenant governor, and speaker of the house of representatives a
- 16 report on progress made in water conservation in this state. The
- 17 report must include specific statutory, budgetary, and policy
- 18 recommendations to improve water conservation and management.
- 19 SECTION 3. Section 16.0121, Water Code, is amended by
- 20 adding Subsections (g) and (h) to read as follows:
- 21 (g) A retail public utility providing potable water that
- 22 receives from the board financial assistance shall use a portion of
- 23 that financial assistance, or any additional financial assistance
- 24 provided by the board for the purpose described by this subsection,

- 1 to mitigate the utility's system water loss if, based on a water
- 2 audit filed by the utility under this section, the water loss meets
- 3 or exceeds the threshold established by board rule.
- 4 (h) For each category of retail public utility listed in
- 5 Subsection (c), the board shall adopt rules regarding:
- 6 (1) the amount of system water loss that requires a
- 7 utility to take action under Subsection (g); and
- 8 (2) the use of financial assistance from the board as
- 9 required by Subsection (g) to mitigate system water loss.
- 10 SECTION 4. Subsection (h), Section 16.055, Water Code, is
- 11 amended to read as follows:
- (h) On receipt of the notice under Subsection (g)(2)(B), <u>a</u>
- 13 [the] person or entity required to develop a drought contingency
- 14 plan shall immediately implement the person's or entity's [water
- 15 conservation plan or drought contingency] plan.
- SECTION 5. Section 17.124, Water Code, is amended to read as
- 17 follows:
- 18 Sec. 17.124. CONSIDERATIONS IN PASSING ON APPLICATIONS. In
- 19 passing on an application from a political subdivision for
- 20 financial assistance for a water supply project, the board shall
- 21 consider:
- (1) the needs of the area to be served by the water
- 23 supply project, the benefit of the water supply project to the area,
- 24 the relationship of the water supply project to the overall,
- 25 statewide water needs, and the relationship of the water supply
- 26 project to the state water plan; [and]
- 27 (2) the availability of revenue to the political

- 1 subdivision, from all sources, for the ultimate repayment of the
- 2 cost of the water supply project, including interest; and
- 3 (3) whether the political subdivision has implemented
- 4 its drought contingency plan when required.
- 5 SECTION 6. Subsection (g), Section 16.0121, Water Code, as
- 6 added by this Act, applies only to system water loss based on a
- 7 water audit filed with the Texas Water Development Board under
- 8 Section 16.0121, Water Code, on or after January 1, 2014.
- 9 SECTION 7. Not later than January 1, 2014, the Texas Water
- 10 Development Board shall adopt rules to implement Subsection (h),
- 11 Section 16.0121, Water Code, as added by this Act.
- 12 SECTION 8. Section 17.124, Water Code, as amended by this
- 13 Act, applies only to the consideration of whether a political
- 14 subdivision has implemented its drought contingency plan on or
- 15 after the effective date of this Act.
- SECTION 9. This Act takes effect September 1, 2013.
