The training must provide the officer with information 1 and instruction related to the officer's duties, including 2 3 information and instruction concerning: 4 (1) the juvenile justice system of this state, 5 including the juvenile correctional facility system; 6 (2) security procedures; 7 the supervision of children committed to the (3) 8 department; 9 (4) signs of suicide risks and suicide precautions; signs and symptoms of the abuse, assault, neglect, 10 (5) and exploitation of a child, including sexual abuse and sexual 11 assault, and the manner in which to report the abuse, assault, 12 neglect, or exploitation of a child; 13 (6) the neurological, physical, and psychological 14 15 development of adolescents; 16 (7) department rules and regulations, including 17 rules, regulations, and tactics concerning the use of force; (8) appropriate restraint techniques; 18 the Prison Rape Elimination Act of 2003 (42 U.S.C. 19 (9) Section 15601, et seq.); 20 (10) the rights and responsibilities of children in 21 the custody of the department; 22 interpersonal relationship skills; 23 (11)24 (12) the social and cultural lifestyles of children in the custody of the department; 25 (13) first aid and cardiopulmonary resuscitation; 26 27 (14) counseling techniques;
