21	SECTION 2. The Honor and Remember flag is designated as the

- 1 service and their families.
- 2 SECTION 3. The Honor and Remember flag's red field
- 3 represents the blood shed by brave men and women who sacrificed
- 4 their lives for freedom, and the flag's white border recognizes the
- 5 purity of that sacrifice. The flag's blue star is a symbol of
- 6 active service in military conflict that dates back to World War I.
- 7 The flag's gold star signifies the ultimate sacrifice of a warrior
- 8 in active service who is not returning home and reflects the value
- 9 of the life given. The folded flag element highlights this nation's
- 10 final tribute to a fallen service member and a family's sacrifice.
- 11 The flag's flame symbolizes the eternal spirit of the departed.
- 12 SECTION 4. This Act takes effect immediately if it receives
- 13 a vote of two-thirds of all the members elected to each house, as
- 14 provided by Section 39, Article III, Texas Constitution. If this
