- 5 SECTION 1. Section 421.024, Government Code, is amended to

- 17 SECTION 2. Section 421.026, Government Code, is amended to
- 18 read as follows:
- 19 Sec. 421.026. REPORT. The council shall annually submit to
- 20 the governor a report stating:

- 22 coordinating a statewide critical infrastructure protection
- 23 strategy;
- [(2)] the status and funding of state programs

- 1 designed to detect and deter homeland security emergencies,
- 2 including the status and funding of counterterrorism efforts;
- 3 (2) $[\frac{(3)}{(3)}]$ recommendations on actions to reduce
- 4 threats to homeland security, including threats related to

- (3) $[\frac{(4)}{(4)}]$ recommendations for improving the alert,

- 8 SECTION 3. Section 421.045, Government Code, is amended to
- 9 read as follows:
- Sec. 421.045. DUTIES. Each permanent special advisory
- 11 committee created under this subchapter shall advise the governor
- 12 on:
- 13 (1) [the development and coordination of a statewide
- 14 critical infrastructure protection strategy;
- 15 $\left[\frac{(2)}{2}\right]$ the implementation of the governor's homeland
- 16 security strategy by state and local agencies and provide specific
- 17 suggestions for helping those agencies implement the strategy;
- 18 (2) [(3)] specific priorities related to the
- 19 governor's homeland security strategy that the committee
- 20 determines to be of significant importance to the statewide
- 21 security of critical infrastructure; and
- (3) (4) other matters related to the planning,
- 23 development, coordination, and implementation of initiatives to

- 25 SECTION 4. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
