8 SECTION 3. Section 421.045, Government Code, is amended to 9 read as follows:

10 Sec. 421.045. DUTIES. Each permanent special advisory 11 committee created under this subchapter shall advise the governor 12 on:

13 (1) [the development and coordination of a statewide 14 critical infrastructure protection strategy;

15 [(2)] the implementation of the governor's homeland 16 security strategy by state and local agencies and provide specific 17 suggestions for helping those agencies implement the strategy;

18 (2) [<del>(3)</del>] specific priorities related the to governor's homeland strategy that 19 security the committee 20 determines to be of significant importance to the statewide security of critical infrastructure; and 21

22 (3) [(4)] other matters related to the planning, 23 development, coordination, and implementation of initiatives to 24 promote the governor's homeland security strategy.

25 SECTION 4. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this
