 1-16 AN ACT

1-17 relating to the punishment for violating certain rules or permit
 1-18 terms under a permit to trap, transport, and transplant certain
 1-19 animals.

1-20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-21 SECTION 1. Section 43.062, Parks and Wildlife Code, is
 1-22 amended to read as follows:

1-23 Sec. 43.062. PENALTY. (a) Except as provided by
 1-24 Subsection (b), a [A] person who violates any provision of this
 1-25 subchapter or the terms of a permit issued under this subchapter
 1-26 commits an offense that is a Class B Parks and Wildlife Code
 1-27 misdemeanor.

1-28 (b) A person commits an offense that is a Class C Parks and
 1-29 Wildlife Code misdemeanor if the person violates:

1-30 (1) a rule relating to a reporting requirement for a
 1-31 permit issued under this subchapter; or

1-32 (2) a term of a permit issued under this subchapter
 1-33 that relates to a reporting requirement.

1-34 SECTION 2. The changes in law made by this Act apply only to
 1-35 an offense committed on or after the effective date of this Act. An
 1-36 offense committed before the effective date of this Act is covered
 1-37 by the law in effect when the offense was committed, and the former
 1-38 law is continued in effect for that purpose. For purposes of this
 1-39 section, an offense was committed before the effective date of this
 1-40 Act if any element of the offense was committed before that date.

1-41 SECTION 3. This Act takes effect immediately if it receives
 1-42 a vote of two-thirds of all the members elected to each house, as
 1-43 provided by Section 39, Article III, Texas Constitution. If this
 1-44 Act does not receive the vote necessary for immediate effect, this
 1-45 Act takes effect September 1, 2013.
