9	REGARDING BENEFITS OF TIMELY GRADUATION. (a) In this section,
10	"general academic teaching institution" and "public state college"
11	have the meanings assigned by Section 61.003.
12	(b) This section applies only to a general academic teaching
13	institution other than a public state college.
14	(c) An institution to which this section applies shall
15	provide to each first-time entering undergraduate student,
16	including each undergraduate student who transfers to the
17	institution, information in electronic or paper format that
18	includes, based on a reasonable projection by the institution using
19	the most recently available data:
20	(1) a comparison of the average total amounts of
21	tuition and fees paid by a full-time student who graduates from the
22	institution in the following number of academic years:
23	(A) four years;
24	(B) five years; and

- 1 (C) six years; and
- 2 (2) an estimate of the average earnings lost by a
- 3 recent graduate of the institution as a result of graduating after
- 4 five or six years instead of four years.
- 5 (d) An institution to which this section applies shall
- 6 include with the information provided to a student under Subsection
- 7 (c):
- 8 <u>(1) a list of actions that the student can take to</u>
- 9 facilitate graduating from the institution in a timely manner; and
- 10 (2) contact information for available academic,
- 11 career, and other related support services at the institution to
- 12 assist the student in that effort.
- 13 (e) An institution to which this section applies may satisfy
- 14 the requirements of Subsections (c)(1) and (2) with regard to a
- 15 student by providing the student with information that is more
- 16 specific than the information described by those subdivisions.
- 17 SECTION 2. Section 51.9195, Education Code, as added by
- 18 this Act, applies beginning with undergraduate students who
- 19 initially enroll in a general academic teaching institution for the
- 20 2014 fall semester.
- 21 SECTION 3. This Act takes effect September 1, 2013.
