Subsection (a), Section 37.001, Education Code, 5 6 is amended to read as follows: 7 (a) The board of trustees of an independent school district shall, with the advice of its district-level committee established 8

8 shall, with the advice of its district-level committee established 9 under Subchapter F, Chapter 11, adopt a student code of conduct for 10 the district. The student code of conduct must be posted and 11 prominently displayed at each school campus or made available for 12 review at the office of the campus principal. In addition to 13 establishing standards for student conduct, the student code of 14 conduct must:

(1) specify the circumstances, in accordance with this subchapter, under which a student may be removed from a classroom, campus, [or] disciplinary alternative education program<u>, or school</u> <u>bus</u>;

19 (2) specify conditions that authorize or require a
20 principal or other appropriate administrator to transfer a student
21 to a disciplinary alternative education program;

(3) outline conditions under which a student may be
suspended as provided by Section 37.005 or expelled as provided by
Section 37.007;

1 (4) specify that consideration will be given, as a 2 factor in each decision concerning suspension, removal to a disciplinary alternative education program, 3 expulsion, or placement in a juvenile justice alternative education program, 4 regardless of whether the decision concerns a mandatory or 5 discretionary action, to: 6 7 (A) self-defense; (B) intent or lack of intent at the time the 8 9 student engaged in the conduct; 10 (C) a student's disciplinary history; or 11 (D) a disability that substantially impairs the student's capacity to appreciate the wrongfulness of the student's 12 13 conduct; (5) provide guidelines for setting the length of a 14 15 term of: 16 (A) a removal under Section 37.006; and 17 (B) an expulsion under Section 37.007; 18 (6) address the notification of a student's parent or guardian of a violation of the student code of conduct committed by 19 20 the student that results in suspension, removal to a disciplinary alternative education program, or expulsion; 21 22 (7) prohibit bullying, harassment, and making hit lists and ensure that district employees 23 enforce those 24 prohibitions; and 25 (8) provide, as appropriate for students at each grade level, methods, including options, for: 26 (A) managing students in the classroom and on 27

(B) disciplining students; and

3 (C) preventing and intervening in student 4 discipline problems, including bullying, harassment, and making 5 hit lists.

6 SECTION 2. Subchapter A, Chapter 37, Education Code, is 7 amended by adding Section 37.0022 to read as follows:

8 <u>Sec. 37.0022. REMOVAL BY SCHOOL BUS DRIVER. (a) The driver</u> 9 <u>of a school bus transporting students to or from school or a</u> 10 <u>school-sponsored or school-related activity may send a student to</u> 11 <u>the principal's office to maintain effective discipline on the</u> 12 <u>school bus. The principal shall respond by employing appropriate</u> 13 <u>discipline management techniques consistent with the student code</u> 14 <u>of conduct adopted under Section 37.001.</u>

15 (b) Section 37.004 applies to any placement under 16 Subsection (a) of a student with a disability who receives special 17 education services.

SECTION 3. This Act applies beginning with the 2013-2014 school year.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.
