- 22 (c-2) A student may earn a distinguished performance
- 23 acknowledgment on the student's diploma and transcript by
- 24 satisfying the requirements for that acknowledgment adopted by the
- 25 State Board of Education by rule. An acknowledgment under this
- 26 subsection may be earned:
- 27 <u>(1) for outstanding performance:</u>

1	(A) in a dual credit course;
