- 2 relating to Internet broadcasts of open meetings held by
- 3 governmental bodies, including regional tollway authorities,
- 4 regional mobility authorities, and metropolitan planning
- 5 organizations.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Subsection (c), Section 551.128, Government
- 8 Code, is amended to read as follows:
- 9 (c) A governmental body that broadcasts a meeting over the
- 10 Internet shall establish an Internet site and provide access to the
- 11 broadcast, without charge, from that site. The governmental body
- 12 shall provide on the Internet site the same notice of the meeting
- 13 that the governmental body is required to post under Subchapter C.
- 14 The notice on the Internet must be posted within the time required
- 15 for posting notice under Subchapter C.
- SECTION 2. Subchapter F, Chapter 366, Transportation Code,
- 17 is amended by adding Section 366.263 to read as follows:
- 18 Sec. 366.263. INTERNET BROADCAST OF OPEN MEETINGS. In a
- 19 manner that complies with Section 551.128(c), Government Code, an
- 20 <u>authority shall broadcast over the Internet live video and audio of</u>
- 21 <u>each open meeting held by the authority.</u> Subsequently, the
- 22 authority shall make available through the authority's Internet
- 23 website archived video and audio for each meeting for which live
- 24 video and audio was provided under this section.

- 1 SECTION 3. Subchapter F, Chapter 370, Transportation Code,
- 2 is amended by adding Section 370.263 to read as follows:
- 3 Sec. 370.263. INTERNET BROADCAST OF OPEN MEETINGS. In a
- 4 manner that complies with Section 551.128(c), Government Code, an
- 5 authority shall broadcast over the Internet live video and audio of
- 6 each open meeting held by the authority. Subsequently, the
- 7 authority shall make available through the authority's Internet
- 8 website archived video and audio for each meeting for which live
- 9 video and audio was provided under this section. This section does
- 10 not apply to an authority composed of three or more counties.
- 11 SECTION 4. Subchapter D, Chapter 472, Transportation Code,
- 12 is amended by adding Section 472.036 to read as follows:
- 13 Sec. 472.036. INTERNET BROADCAST OF OPEN MEETINGS. In a
- 14 manner that complies with Section 551.128(c), Government Code, a
- 15 metropolitan planning organization shall broadcast over the
- 16 Internet live video and audio of each open meeting held by the
- 17 organization. Subsequently, the organization shall make available
- 18 through the organization's Internet website archived video and
- 19 audio for each meeting for which live video and audio was provided
- 20 under this section.
- 21 SECTION 5. The changes in law made by this Act apply only to
- 22 an open meeting held on or after the effective date of this Act.
- 23 SECTION 6. This Act takes effect September 1, 2013.
