A BILL TO BE ENTITLED

AN ACT

2 relating to Internet broadcasts of open meetings held by 3 governmental bodies, including regional tollway authorities, 4 regional mobility authorities, and metropolitan planning 5 organizations.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Subsection (c), Section 551.128, Government 8 Code, is amended to read as follows:

9 (c) A governmental body that broadcasts a meeting over the 10 Internet shall establish an Internet site and provide access to the 11 broadcast<u>, without charge</u>, from that site. The governmental body 12 shall provide on the Internet site the same notice of the meeting 13 that the governmental body is required to post under Subchapter C. 14 The notice on the Internet must be posted within the time required 15 for posting notice under Subchapter C.

SECTION 2. Subchapter F, Chapter 366, Transportation Code, is amended by adding Section 366.263 to read as follows:

18 Sec. 366.263. INTERNET BROADCAST OF OPEN MEETINGS. In a 19 manner that complies with Section 551.128(c), Government Code, an 20 authority shall broadcast over the Internet live video and audio of 21 each open meeting held by the authority. Subsequently, the 22 authority shall make available through the authority's Internet 23 website archived video and audio for each meeting for which live 24 video and audio was provided under this section.

SECTION 3. Subchapter F, Chapter 370, Transportation Code,
 is amended by adding Section 370.263 to read as follows:

Sec. 370.263. INTERNET BROADCAST OF OPEN MEETINGS. In a 3 manner that complies with Section 551.128(c), Government Code, an 4 authority shall broadcast over the Internet live video and audio of 5 each open meeting held by the authority. Subsequently, the 6 7 authority shall make available through the authority's Internet website archived video and audio for each meeting for which live 8 9 video and audio was provided under this section. This section does not apply to an authority composed of three or more counties. 10

SECTION 4. Subchapter D, Chapter 472, Transportation Code,
is amended by adding Section 472.036 to read as follows:

13 Sec. 472.036. INTERNET BROADCAST OF OPEN MEETINGS. In a manner that complies with Section 551.128(c), Government Code, a 14 <u>metropolitan planning organization shall b</u>roadcast over 15 the 16 Internet live video and audio of each open meeting held by the organization. Subsequently, the organization shall make available 17 18 through the organization's Internet website archived video and audio for each meeting for which live video and audio was provided 19 20 under this section.

21 SECTION 5. The changes in law made by this Act apply only to 22 an open meeting held on or after the effective date of this Act.

SECTION 6. This Act takes effect September 1, 2013.
