- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 401.156, Insurance Code, is amended to
- 6 read as follows:
- 7 Sec. 401.156. DEPOSIT AND USE OF ASSESSMENT AND FEE.
- 8 (a) The department shall deposit any assessments or fees collected
- 9 under this subchapter relating to the examination of insurers and
- 10 other regulated entities by the financial examinations division or
- 11 actuarial division, as those terms are defined by Section 401.251,
- 12 to the credit of an account with the Texas Treasury Safekeeping
- 13 Trust Company to be used exclusively to pay examination costs, as
- 14 defined by Section 401.251, reimbursement of the Texas Department
- 15 of Insurance operating account for administrative support costs,
- 16 and reimbursement of premium tax credits for examination costs and
- 17 <u>examination overhead assessments</u>. [Money deposited under this
- 18 subsection accumulates and may be disbursed to the department in a
- 19 manner consistent with Subchapter F.
- 20 (b) Money deposited under Subsection (a) accumulates and
- 21 may be disbursed to the department in a manner consistent with that
- 22 <u>subsection and Subchapter F.</u>
- 23 (c) Revenue that is not related to the examination of
- 24 insurers or other regulated entities by the financial examinations

- 1 division or actuarial division shall be deposited to the credit of
- 2 the Texas Department of Insurance operating account.
- 3 $\underline{\text{(d)}}$ $\underline{\text{(d)}}$ To the extent that another provision of law
- 4 conflicts with this section or a provision of this section, this
- 5 section or the provision of this section controls.
- 6 (e) $[\frac{d}{d}]$ The department may transfer funds between the
- 7 account described by Subsection (a) and the Texas Department of
- 8 Insurance operating account as necessary to ensure that funds are
- 9 deposited to the correct account and used for the correct purposes.
- 10 This subsection does not authorize a disbursement or transfer of
- 11 funds in a manner that is inconsistent with the purpose of
- 12 Subchapter F and this section.
- 13 SECTION 2. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2013.
