16	Sec. 61.9832. ELIGIBILITY; AGREEMENT REQUIREMENTS.
17	(a) To be eligible to receive loan repayment assistance under this
18	<pre>subchapter, a person must:</pre>
19	(1) apply annually for the loan repayment assistance
20	in the manner prescribed by the board;
21	(2) be a United States citizen;
22	(3) have completed an undergraduate or graduate
23	<pre>program in mathematics or science;</pre>
24	(4) have a cumulative grade point average of at least

- 1 3.5 on a four-point scale or the equivalent;
- 2 (5) be certified under Subchapter B, Chapter 21, to
- 3 teach mathematics or science in a public school in this state or be

- 6 Certification and is provided by an institution of higher education
- 7 or by a private or independent institution of higher education in

- 27 (b) The board shall reduce the amount of a single assistance

- 6 Sec. 61.9834. EXCEPTION TO CONSECUTIVE YEARS OF EMPLOYMENT
- 7 REQUIREMENT. The board shall excuse an otherwise eligible person
- 8 from a requirement imposed by Section 61.9832 that the employment
- 9 qualifying the person for loan repayment assistance be performed in
- 10 consecutive years if the break in employment is a result of the
- 11 person's:
- 12 (1) full-time enrollment in a course of study related
- 13 to the field of teaching that is approved by the State Board for
- 14 Educator Certification and provided by an institution of higher
- 15 education or by a private or independent institution of higher
- 16 education in this state;
- 17 (2) service on active duty as a member of the armed
- 18 forces of the United States, including as a member of a reserve or

- 4 Sec. 61.9835. ELIGIBLE LOANS. (a) The board may provide
- 5 repayment assistance under this subchapter for the repayment of any

- 8 <u>institution of higher education; and</u>
- 9 (2) is received by an eligible person through an
- 10 eligible lender.
- 11 (b) If the loan is not a state or federal guaranteed student

- (f) The legislature may not appropriate general revenue to

- Sec. 61.9838. AMOUNT OF LOAN REPAYMENT ASSISTANCE.
- 21 (a) The total amount of loan repayment assistance paid by the
- 22 board under this subchapter may not exceed the total amount of money
- 23 available in the fund under Section 61.9837.
- (b) Not more than 4,000 eligible persons may be provided
- 25 loan repayment assistance under this subchapter in any school year.
- 26 (b-1) This subsection expires January 1, 2020.
- 27 Notwithstanding Subsection (b), not more than the following number

- 1 of eligible persons may be provided loan repayment assistance under
- 2 this subchapter in the specified school year:
- 3 (1) in the 2016-2017 school year, not more than 1,000
- 4 eligible persons may be provided loan repayment assistance;

- 21 (a) An eligible person may continue to receive loan repayment
- 22 assistance if the person continues to teach in a public school
- 23 described by Section 61.9832(a)(7) after the first four years
- 24 required for eligibility under Section 61.9832(c)(2).
- 25 (b) If an eligible person transfers to a public school
- 26 <u>located in a school district that does not receive funding under</u>
- 27 Title I, Elementary and Secondary Education Act of 1965 (20 U.S.C.

- 1 Section 6301 et seq.), after the first four years required for
- 2 eligibility under Section 61.9832(c)(2), the person may not receive

- 9 Sec. 61.9840. RULES. The board shall adopt rules necessary
- 10 for the administration of this subchapter, including a rule

- 13 repayment assistance; and
- (2) a method of awarding assistance under this
- 15 subchapter that:
- 16 (A) gives first priority to applicants who are
- 17 renewing their applications for loan repayment assistance provided

- 2 verifies the applicant's year of employment.
- 3 SECTION 2. The Texas Higher Education Coordinating Board
- 4 shall begin providing loan repayment assistance under Subchapter
- 5 II, Chapter 61, Education Code, as added by this Act, for eligible
- 6 persons teaching in the 2016-2017 school year.
- 7 SECTION 3. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
