SECTION 1. Subsection (a), Section 2.01, Chapter 1342, Acts of the 77th Legislature, Regular Session, 2001, is amended to read as follows:

(a) The district is governed by a board of five directors [elected as provided by Section 2.04].

To the extent authorized by Section 52, Article III, (a) Texas Constitution, the district may construct, acquire, improve, maintain, or operate macadamized, graveled, or paved roads or turnpikes, or improvements in aid of those roads or turnpikes, including entrance and exit ramps to and from State Highway 99, also

known as the Grand Parkway [inside the district].

SECTION 3. The heading to Section 7.03, Chapter 1342, Acts of the 77th Legislature, Regular Session, 2001, is amended to read as follows:

SECTION 7.03. LAW GOVERNING DIVIDED DISTRICT; APPOINTMENT AND ELECTION OF DIRECTORS.

SECTION 4. Subsections (a) and (e), Section 7.03, Chapter Acts of the 77th Legislature, Regular Session, 2001, are amended to read as follows:

- (a) A district resulting from a division under this article is a separate district and is governed as a separate district. This chapter applies to any new district created by the division of the district, and a new district has all the powers and duties of the district. (e)
