- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter H, Chapter 51, Government Code, is
- 6 amended by adding Section 51.709 to read as follows:
- 7 Sec. 51.709. ADDITIONAL FILING FEE FOR CIVIL CASES IN
- 8 ROCKWALL COUNTY. (a) This section applies only to district
- 9 courts, statutory probate courts, county courts at law, and justice
- 10 courts in Rockwall County.
- 11 (b) Except as otherwise provided by this section and in
- 12 addition to all other fees authorized or required by other law, the
- 13 clerk of a court shall collect a filing fee of not more than \$15 in
- 14 each civil case filed in the court to be used for the construction,
- 15 renovation, or improvement of the facilities that house the courts
- 16 collecting the fee.
- 17 (c) Court fees due under this section shall be collected in
- 18 the same manner as other fees, fines, or costs are collected in the
- 19 <u>case.</u>
- 20 (d) The clerk shall send the fees collected under this
- 21 section to the county treasurer at least as frequently as monthly.
- 22 The treasurer shall deposit the fees in a special account in the
- 23 county treasury dedicated to the construction, renovation, or
- 24 improvement of the facilities that house the courts collecting the

- 1 fee.
- 2 (e) This section applies only to fees for a 12-month period
- 3 beginning July 1, if the commissioners court:
- 4 (1) adopts a resolution authorizing a fee of not more
- 5 <u>than \$15; and</u>
- 6 (2) files the resolution with the county treasurer not
- 7 later than June 1 immediately preceding the first 12-month period
- 8 <u>during which the fees are to be collected.</u>
- 9 <u>(f) A resolution adopted under Subsection (e) continues</u>
- 10 from year to year until July 1, 2025, allowing the county to collect
- 11 fees under the terms of this section until the resolution is
- 12 rescinded.
- 13 (g) The commissioners court may rescind the resolution
- 14 adopted under Subsection (e) by adopting a resolution rescinding
- 15 the resolution and submitting the recision resolution to the county
- 16 <u>treasurer not later than June 1 preceding the beginning of the first</u>
- 17 day of the county fiscal year. The commissioners court may adopt an

- 25 FACILITIES COLLECTED BY CLERK. The clerk of a justice court in
- 26 Rockwall County shall collect an additional filing fee of not more
- 27 than \$15 under Section 51.709 in civil cases to fund the

- 1 construction, renovation, or improvement of court facilities, if
- 2 <u>authorized by the county commissioners court.</u>
- 3 SECTION 6. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2013.
