S.B. No. 1841

A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Harris County Water Control and Improvement District No. 161; granting the power of eminent domain; 3 providing authority to issue bonds; providing authority to impose 4 5 assessments, fees, or taxes. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Subtitle I, Title 6, Special District Local Laws 7 Code, is amended by adding Chapter 9047 to read as follows: 8 CHAPTER 9047. HARRIS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT 9 NO. 161 10 11 SUBCHAPTER A. GENERAL PROVISIONS 12 Sec. 9047.001. DEFINITIONS. In this chapter: "Board" means the district's board of directors. 13 (1) (2) "Commission" means the <u>Texas</u> Commission on 14 15 Environmental Quality. 16 (3) "Director" means a board member. (4) "District" means the Harris County Water Control 17 and Improvement District No. 161. 18 Sec. 9047.002. NATURE OF DISTRICT. The district is a water 19 control and improvement district created under Section 59, Article 20 XVI, Texas Constitution. 21 Sec. 9047.003. CONFIRMATION AND DIRECTORS' ELECTION 22 23 REQUIRED. The temporary directors shall hold an election to confirm the creation of the district and to elect five permanent 24

1	directors as provided by Section 49.102, Water Code.
2	Sec. 9047.004. CONSENT OF MUNICIPALITY REQUIRED. The
3	temporary directors may not hold an election under Section 9047.003
4	until each municipality in whose corporate limits or
5	extraterritorial jurisdiction the district is located has
6	consented by ordinance or resolution to the creation of the
7	district and to the inclusion of land in the district.
8	Sec. 9047.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
9	The district is created to serve a public purpose and benefit.
10	(b) The district is created to accomplish the purposes of:
11	(1) a water control and improvement district as
12	provided by general law and Section 59, Article XVI, Texas
13	Constitution; and
14	(2) Section 52, Article III, Texas Constitution, that
15	relate to the construction, acquisition, improvement, operation,
16	or maintenance of macadamized, graveled, or paved roads, or
17	improvements, including storm drainage, in aid of those roads.
18	Sec. 9047.006. INITIAL DISTRICT TERRITORY. (a) The
19	district is initially composed of the territory described by
20	Section 2 of the Act creating this chapter.
21	(b) The boundaries and field notes contained in Section 2 of
22	the Act creating this chapter form a closure. A mistake made in the
23	field notes or in copying the field notes in the legislative process
24	does not affect the district's:
25	(1) organization, existence, or validity;
26	(2) right to issue any type of bond for the purposes
27	for which the district is created or to pay the principal of and

1	interest on a bond;
2	(3) right to impose a tax; or
3	(4) legality or operation.
4	Sec. 9047.007. APPLICABILITY OF LAW GOVERNING METROPOLITAN
5	WATER CONTROL AND IMPROVEMENT DISTRICTS. (a) Except as otherwise
6	provided by this chapter, Chapter 702 (S.B. 1358), Acts of the 68th
7	Legislature, Regular Session, 1983 (Article 717r, Vernon's Texas
8	<u>Civil Statutes</u>), applies to the district.
9	(b) Section 3, Chapter 702 (S.B. 1358), Acts of the 68th
10	Legislature, Regular Session, 1983 (Article 717r, Vernon's Texas
11	<u>Civil Statutes</u>), does not apply to the district.
12	SUBCHAPTER B. BOARD OF DIRECTORS
13	Sec. 9047.051. GOVERNING BODY; TERMS. (a) The district is
14	governed by a board of five elected directors.
15	(b) Except as provided by Section 9047.052, directors serve
16	staggered four-year terms.
17	Sec. 9047.052. TEMPORARY DIRECTORS. (a) The temporary
18	board consists of:
19	<pre>(1) Jeff Safe;</pre>
20	(2) Katy Walston;
21	(3) Brandon Buell;
22	(4) Bob Mueller; and
23	(5) Chad Meacham.
24	(b) Temporary directors serve until the earlier of:
25	(1) the date permanent directors are elected under
26	Section 9047.003; or
27	(2) the fourth anniversary of the effective date of

1	the Act creating this chapter.
2	(c) If permanent directors have not been elected under
3	Section 9047.003 and the terms of the temporary directors have
4	expired, successor temporary directors shall be appointed or
5	reappointed as provided by Subsection (d) to serve terms that
6	expire on the earlier of:
7	(1) the date permanent directors are elected under
8	Section 9047.003; or
9	(2) the fourth anniversary of the date of the
10	appointment or reappointment.
11	(d) If Subsection (c) applies, the owner or owners of a
12	majority of the assessed value of the real property in the district
13	may submit a petition to the commission requesting that the
14	commission appoint as successor temporary directors the five
15	persons named in the petition. The commission shall appoint as
16	successor temporary directors the five persons named in the
17	petition.
18	SUBCHAPTER C. POWERS AND DUTIES
19	Sec. 9047.101. GENERAL POWERS AND DUTIES. The district has
20	the powers and duties necessary to accomplish the purposes for
21	which the district is created.
22	Sec. 9047.102. WATER CONTROL AND IMPROVEMENT DISTRICT
23	POWERS AND DUTIES. The district has the powers and duties provided
24	by the general law of this state, including Chapters 49 and 51,
25	Water Code, applicable to water control and improvement districts
26	created under Section 59, Article XVI, Texas Constitution.
27	Sec. 9047.103. AUTHORITY FOR ROAD PROJECTS. Under Section

1 52, Article III, Texas Constitution, the district may design, 2 acquire, construct, finance, issue bonds for, improve, operate, 3 maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or 4 5 improvements, including storm drainage, in aid of those roads. 6 Sec. 9047.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road 7 project must meet all applicable construction standards, zoning and 8 subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road 9 10 project is located. (b) If <u>a road project is not located in the corporate limits</u> 11 12 or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, zoning and 13 subdivision requirements, and regulations of each county in which 14 the road project is located. 15 (c) If the state will maintain and operate the road, the 16 17 Texas Transportation Commission must approve the plans and specifications of the road project. 18 19 Sec. 9047.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all applicable 20 requirements of any ordinance or resolution that is adopted by the 21 22 City of Houston, Texas, that consents to the creation of the district or to the inclusion of land in the district. 23 24 Sec. 9047.106. LIMITATION ON USE OF EMINENT DOMAIN. The district may not exercise the power of eminent domain outside the 25

8	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
9	Sec. 9047.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
10	district may issue, without an election, bonds and other
11	obligations secured by:
12	(1) revenue other than ad valorem taxes; or
13	(2) contract payments described by Section 9047.153.
14	(b) The district must hold an election in the manner
15	provided by Chapters 49 and 51, Water Code, to obtain voter approval
16	before the district may impose an ad valorem tax or issue bonds
17	payable from ad valorem taxes.
18	(c) The district may not issue bonds payable from ad valorem
19	taxes to finance a road project unless the issuance is approved by a
20	vote of a two-thirds majority of the district voters voting at an
21	election held for that purpose.
22	Sec. 9047.152. OPERATION AND MAINTENANCE TAX. (a) If
23	authorized at an election held under Section 9047.151, the district
24	may impose an operation and maintenance tax on taxable property in
25	the district in accordance with Section 49.107, Water Code.
26	(b) The board shall determine the tax rate. The rate may not
27	exceed the rate approved at the election.

Sec. 9047.153. CONTRACT TAXES. (a) In accordance with Section 49.108, Water Code, the district may impose a tax other than an operation and maintenance tax and use the revenue derived from the tax to make payments under a contract after the provisions of the contract have been approved by a majority of the district voters voting at an election held for that purpose.

7 (b) A contract approved by the district voters may contain a
8 provision stating that the contract may be modified or amended by
9 the board without further voter approval.

10 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS Sec. 9047.201. AUTHORITY TO ISSUE 11 BONDS AND OTHER 12 OBLIGATIONS. The district may issue bonds or other obligations payable wholly or partly from ad valorem taxes, impact fees, 13 revenue, contract payments, grants, or other district money, or any 14 15 combination of those sources, to pay for any authorized district 16 purpose.

Sec. 9047.202. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner provided by Section 51.433, Water Code.

23 <u>Sec. 9047.203. BONDS FOR ROAD PROJECTS. At the time of</u> 24 <u>issuance, the total principal amount of bonds or other obligations</u> 25 <u>issued or incurred to finance road projects and payable from ad</u> 26 <u>valorem taxes may not exceed one-fourth of the assessed value of the</u> 27 real property in the district.

8 SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this 9 10 Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, 11 12 officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, 13 14 Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Province Provinc

The Texas Commission on Environmental Quality has filed 18 (c) 19 its recommendations relating to this Act with the governor, the house 20 lieutenant governor, and the speaker of the of representatives within the required time. 21

(d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

26 SECTION 4. (a) Section 9047.106, Special District Local 27 Laws Code, as added by Section 1 of this Act, takes effect only if

1 this Act receives a two-thirds vote of all the members elected to 2 each house.

3 (b) If this Act does not receive a two-thirds vote of all the 4 members elected to each house, Subchapter C, Chapter 9047, Special 5 District Local Laws Code, as added by Section 1 of this Act, is 6 amended by adding Section 9047.106 to read as follows:

Sec. 9047.106. NO EMINENT DOMAIN POWER. The district may
 not exercise the power of eminent domain.

9 (c) This section is not intended to be an expression of a 10 legislative interpretation of the requirements of Section 17(c), 11 Article I, Texas Constitution.

12 SECTION 5. This Act takes effect immediately if it receives 13 a vote of two-thirds of all the members elected to each house, as 14 provided by Section 39, Article III, Texas Constitution. If this 15 Act does not receive the vote necessary for immediate effect, this 16 Act takes effect September 1, 2013.
