11	Sec. 8471.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Commission" means the Texas Commission on
14	Environmental Quality.
15	(3) "Director" means a board member.
16	(4) "District" means the Needmore Ranch Municipal
17	Utility District No. 1.
18	Sec. 8471.002. NATURE OF DISTRICT. The district is a
19	municipal utility district created under Section 59, Article XVI,
20	Texas Constitution.
21	Sec. 8471.003. CONFIRMATION AND DIRECTORS' ELECTION
22	REQUIRED. The temporary directors shall hold an election to
23	confirm the creation of the district and to elect five permanent
24	directors as provided by Section 49.102, Water Code.

- 1 Sec. 8471.004. CONSENT OF MUNICIPALITY REQUIRED. The
- 2 temporary directors may not hold an election under Section 8471.003
- 3 until each municipality in whose corporate limits or
- 4 extraterritorial jurisdiction the district is located has
- 5 consented by ordinance or resolution to the creation of the
- 6 district and to the inclusion of land in the district.
- 7 Sec. 8471.005. LEGISLATIVE FINDINGS OF PUBLIC PURPOSE AND
- 8 BENEFIT. (a) The district is created to serve a public purpose and
- 9 benefit.
- 10 (b) The creation of the district is essential to accomplish
- 11 the purposes of:
- 12 (1) a municipal utility district as provided by
- 13 general law and Section 59, Article XVI, Texas Constitution;
- 14 (2) Section 52, Article III, Texas Constitution, that
- 15 relate to the construction, acquisition, improvement, operation,
- 16 or maintenance of macadamized, graveled, or paved roads, or
- improvements, including storm drainage, in aid of those roads; and
- 18 (3) Section 52-a, Article III, Texas Constitution,
- 19 that relate to the development and diversification of the economy
- 20 of this state.
- (c) The creation of the district is necessary to develop,
- 22 encourage, and maintain safety and the public welfare in the
- 23 district.
- 24 <u>(d) All land and other property in the district will benefit</u>
- 25 from the improvements and services to be provided by the district
- 26 under this chapter.
- (e) The district will:

1 (1) seek and provide funding for the district to maintain and enhance the economic health and vitality of the 2 3 territory in the district as a residential community and business 4 center; and 5 (2) provide for the preservation and conservation of the natural resources within the district, while protecting private 6 7 property rights to develop and beneficially use those resources in an organized and lawfully regulated manner. 8 9 (f) The district will not act as the agent or instrumentality of any private interest even though the district 10 11 will benefit many private interests as well as the public. Sec. 8471.006. INITIAL DISTRICT TERRITORY. (a) The 12 13 district is initially composed of the territory described by Section 2 of the Act enacting this chapter. 14 15 (b) The boundaries and field notes contained in Section 2 of 16 the Act enacting this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 17 18 does not affect the district's: 19 (1) organization, existence, or validity; 20 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 21 22 interest on a bond; 23 (3) right to impose a tax; or 24 (4) legality or operation. 25 SUBCHAPTER B. - 4 <u>SUBCHAPTER C</u>. POWERS AND DUTIES
- 5 Sec. 8471.101. GENERAL POWERS AND DUTIES. The district has
- 6 the powers and duties necessary to accomplish the purposes for
- 7 which the district is created.
- 8 Sec. 8471.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 9 DUTIES. The district has the powers and duties provided by the
- 10 general law of this state, including Chapters 49 and 54, Water Code,
- 11 applicable to municipal utility districts created under Section 59,
- 12 Article XVI, Texas Constitution.
- 13 Sec. 8471.103. RESIDENTIAL OR PLANNED COMMUNITY
- 14 DEVELOPMENT; WASTEWATER TREATMENT FACILITY. (a) In the event that
- 15 a residential subdivision or planned community is developed in the
- 16 territory of the district, the district shall develop a wastewater
- 17 treatment facility in coordination with Hays County and the City of
- 18 Wimberley.
- 19 (b) A developer who proposes to build a residential
- 20 subdivision or planned community in the territory of the district
- 21 must agree to develop the property in a manner that works in
- 22 conjunction with the design and specifications of any wastewater
- 23 treatment facility developed under Subsection (a).
- 24 <u>(c) If a residential subdivision or planned community is</u>

- Sec. 8471.104. LIMITATION ON USE OF EMINENT DOMAIN.

- 1 (a) The district may not exercise the power of eminent domain
- 2 except for the purpose of importing surface water or nonlocal
- 3 groundwater into the district.
- 4 (b) For purposes of this section, nonlocal groundwater
- 5 includes only groundwater that is withdrawn from a source outside
- 6 the Edwards Aquifer and the Trinity Aquifer.
- 7 Sec. 8471.105. LIMITATION ON ANNEXATION. The district may
- 8 not add land by petition of less than all the landowners under
- 9 Section 49.302, Water Code, unless the petition required under that
- 10 section is signed by the owners of a two-thirds majority of the
- 11 assessed value of the land in the defined area described by the
- 12 petition.
- 13 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- 14 Sec. 8471.151. ELECTIONS REGARDING TAXES OR BONDS.
- 15 (a) The district may issue, without an election, bonds and other
- 16 <u>obligations secured by:</u>
- 17 (1) revenue other than ad valorem taxes; or
- 18 (2) contract payments described by Section 8471.153.
- 19 (b) The district must hold an election in the manner
- 20 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 21 before the district may impose an ad valorem tax or issue bonds
- 22 payable from ad valorem taxes.
- Sec. 8471.152. OPERATION AND MAINTENANCE TAX. (a) If
- 24 authorized at an election held under Section 8471.151, the district
- 25 may impose an operation and maintenance tax on taxable property in
- 26 the district in accordance with Section 49.107, Water Code.
- 27 (b) The board shall determine the tax rate. The rate may not

- 1 exceed the rate approved at the election.
- Sec. 8471.153. CONTRACT TAXES. (a) In accordance with
- 3 Section 49.108, Water Code, the district may impose a tax other than
- 4 an operation and maintenance tax and use the revenue derived from
- 5 the tax to make payments under a contract after the provisions of
- 6 the contract have been approved by a majority of the district voters
- 7 voting at an election held for that purpose.
- 8 (b) A contract approved by the district voters may contain a

- 18 Sec. 8471.202. TAXES FOR BONDS. (a) At the time the
- 19 district issues bonds payable wholly or partly from ad valorem
- 20 taxes, the board shall provide for the annual imposition of a
- 21 continuing direct ad valorem tax, without limit as to rate or
- 22 amount, while all or part of the bonds are outstanding as required
- 23 and in the manner provided by Sections 54.601 and 54.602, Water
- 24 <u>Code</u>.
- 25 (b) The board's order to issue bonds and impose an ad
- 26 <u>valorem tax must provide that on retirement of the bonds for which</u>
- 27 the tax is originally authorized, unless a subsequent bond election

- 1 authorizes a continuation of the tax, the imposition of the tax,
- 2 including the district's authority to assess and collect the tax,
- 3 ends.
