8-39 The governor, one of the required recipients, has the notice and Act to the Texas Commission on (b) 8-40 submitted 8-41 Environmental Quality.

8-42 (c) The Texas Commission on Environmental Quality has filed recommendations relating to this Act with the governor, 8-43 its lieutenant governor, and speaker of the house of representatives 8-44 8-45 within the required time.
