6	SECTION 1. Section 434.153, Government Code, is amended to
7	read as follows:
8	Sec. 434.153. COMPOSITION OF COUNCIL. The council is
9	composed of the <u>director or</u> executive head of the following
10	entities [agencies], or that person's designated representative:
11	(1) the Texas Veterans Commission;
12	(2) the Veterans' Land Board;

14	(4) the Health and Human Services Commission; [and]
15	(5) the State Bar of Texas <u>;</u>
16	(6) the office of acquired brain injury of the Health
17	and Human Services Commission;
18	(7) the Department of State Health Services;
19	(8) the Department of Aging and Disability Services;
20	(9) the Department of Assistive and Rehabilitative
21	Services;
22	(10) the Department of Family and Protective Services;
23	(11) the Texas Workforce Commission;
24	(12) the Texas Workforce Investment Council;

1	(13) the Texas Higher Education Coordinating Board;
2	(14) the Texas Department of Licensing and Regulation;
3	(15) the Department of Public Safety;
4	(16) the Texas Department of Criminal Justice;

7	Standards and Education;
8	(19) the Texas Department of Housing and Community

17	SECTION 3. Subsections (a) and (g), Section 434.154,
18	Government Code, are amended to read as follows:

21	affecting veterans, servicemembers, and their families:
22	(1) health or mental health;
23	(2) employment;
24	(3) higher education;
25	(4) criminal justice;

- 2 <u>(8)</u> any other coordinating workgroup considered 3 necessary.
- 4 (g) Each member of the council may invite <u>organizations</u> [one
- 5 <u>organization</u>] or <u>agencies</u> [<u>agency</u>] that <u>provide</u> [<u>provides</u>]
- 6 services to veterans, servicemembers, and their families, but that
