CONCURRENT RESOLUTION

- 1 WHEREAS, Senate Bill No. 2 has been adopted by the senate and
- 2 the house of representatives and is being prepared for enrollment;
- 3 and
- 4 WHEREAS, The bill contains technical errors that should be
- 5 corrected; now, therefore, be it
- 6 RESOLVED by the 83rd Legislature of the State of Texas, That
- 7 the enrolling clerk of the senate be instructed to correct Senate
- 8 Bill No. 2 as follows:
- 9 (1) Add the following appropriately numbered SECTION to the
- 10 bill and renumber subsequent SECTIONS of the bill accordingly:
- 11 SECTION _____. Subchapter D, Chapter 33, Education Code, is
- 12 amended by adding Section 33.088 to read as follows:
- 13 Sec. 33.088. PARTICIPATION IN LEAGUE CONTESTS BY SPECIALTY
- 14 HIGH SCHOOL. (a) In this section:
- 15 <u>(1) "Division" includes academics, athletics, or</u>
- 16 music divisions of league contests.
- 17 (2) "Specialty high school" means the high school of
- 18 <u>an open-enrollment charter school that:</u>
- (A) enrolls students without regard to the
- 20 attendance zones of the school district in which the high school is
- 21 <u>located; and</u>
- 22 <u>(B) is determined by the University</u>
- 23 Interscholastic League to specialize in a division of league
- 24 contests.

- 1 (3) "League" means the University Interscholastic
- 2 <u>League</u>.
- 3 (b) To ensure fair competition, the league shall adopt rules
- 4 governing participation in league contests by students attending a
- 5 specialty high school.
- 6 (c) The league rules adopted under Subsection (b) must
- 7 require that, for any division of league contests that a specialty
- 8 high school emphasizes, the school will be assigned to the
- 9 conference with the largest student enrollment, except that the
- 10 rules may provide for reasonable exceptions from that requirement
- 11 based on travel, availability of participant schools, or other
- 12 criteria.
- 13 (d) League rules adopted under Subsection (b) must apply
- 14 beginning with the 2013-2014 school year. This subsection expires
- 15 August 31, 2014.
- 16 (2) Strike SECTION 48 of the bill (page 46, lines 16-23),
- 17 repealing provisions of the Education Code, and substitute the
- 18 following appropriately numbered SECTION:
- 19 SECTION ____. The following provisions of the Education
- 20 Code are repealed:
- 21 (1) Subsection (b), Section 12.1055;
- 22 (2) Subsection (b), Section 12.113; and
- 23 (3) Subsection (b), Section 12.1161.
