WHEREAS, Throughout his career, he was involved in a range of activities that were in addition to his service as a city administrator; he was a member of the Texas City Management Association, and he was appointed to the Texas Municipal Retirement System Board of Trustees by Governor Rick Perry in 2003; highly regarded by his colleagues, he was a smart and personable man who made friends everywhere he went; and

WHEREAS, In all of his endeavors, Mr. Simpson enjoyed the love and support of his wife of more than two decades, Kelly, and he was the proud father of two sons, Price and Seth, and a daughter, Courtnie; among his favorite pastimes were golf, hunting, and grilling, and especially cheering on his daughter in softball; and

WHEREAS, While the life of Frank Simpson ended far too soon, he leaves behind a legacy that will forever inspire all those who were privileged to know him; now, therefore, be it
