Relating to authorizing the Department of Agriculture to create a database of nonpaying buyers of agricultural products; authorizing a fee.

Relating to the eligibility of land for appraisal for ad valorem tax purposes as qualified open-space land on the basis of its use for wildlife management.

Relating to the establishment of the Texas Rural Development Fund and to the establishment, operation, and funding of certain programs for rural economic development.

Relating to the abolition of wind erosion conservation districts.

Relating to prohibiting the production or distribution of certain records of field trials or the process of hunting or catching wildlife; providing a civil remedy and creating an offense.

Relating to the administration of the citrus budwood certification program and the creation of the citrus nursery stock certification program; providing civil, criminal, and administrative penalties and authorizing fees.

Relating to restricting the sale of state-owned longhorn cattle in state natural areas.

Relating to the regulation of advertising by structural pest control businesses.

Relating to the composition of the structural pest control advisory committee.

Relating to activities conducted in connection with a state or federal disease control or eradication program for animals.

Relating to the establishment of a community development grocery store revolving loan fund program.
