HB 496 Hernandez Luna
Relating to authorizing a suit to declare that certain young people have been abused, neglected, or abandoned and extending the jurisdiction of certain courts making such a declaration.

HB 1652 Miles | et al.
Relating to liability of an owner, lessee, or occupant of land that allows land to be used as a community garden.

HB 1705 Farrar
Relating to the age qualification and extended jurisdiction over one seeking a suit affecting parent child relationship order in family court for purposes of obtaining special immigrant juvenile status.

HB 2131 Dutton
Relating to the creation of a specialty court for certain first-time DWI offenders; imposing fees for participation and alcohol monitoring.

HB 2985 Sanford | et al.
Relating to marriage education courses for certain couples filing for divorce on the grounds of insupportability.

HB 3018 Gutierrez
Relating to amounts paid by a county for the operation and administration of a county or district attorney's office.

HB 3402 Raymond
Relating to the privilege of a child to refuse to testify against the child's parent or guardian.

HB 3725 Naishtat
Relating to the service of a subpoena for the attendance of a law enforcement agency employee.

HB 3728 Raymond
Relating to the privilege of a parent or guardian to refuse to testify against the parent or guardian's child.

HB 3929 Ashby | et al.
Relating to the composition of the 12th and 369th Judicial Districts, the redesignation of the district attorney for the 12th Judicial District as the district attorney for the 369th Judicial District, and the composition of the Leon County juvenile board.

SB 92 Van de Putte | et al.
Relating to the designation of a juvenile court and a program for certain juveniles who may be the victims of human trafficking.

SB 679 Duncan
Relating to certain records and supporting affidavits filed as evidence in certain actions.

SB 1611 Ellis | et al.
Relating to discovery in a criminal case.
