Relating to the certification of alcohol awareness programs required for minors convicted of or receiving deferred disposition for certain alcohol offenses.

Relating to an exemption for certain persons who sell signs from the requirement to be licensed as an electrician.

Relating to the sale of distilled spirits to ultimate consumers by the holder of a distiller's and rectifier's permit.

Relating to the sale by an alcoholic beverage wholesaler of equipment, fixtures, or supplies used in the selling or dispensing of distilled spirits.

Relating to the creation of a permit to allow alcoholic beverage wholesalers to store alcoholic beverages at certain auxiliary locations; providing for a permitting fee.

Relating to an exemption from air conditioning and refrigeration contracting regulation for installation of a thermostat.

Relating to production requirements for holders of winery permits.

HB 2690 Elkins
Relating to the sale of a motor vehicle by an unlicensed seller.

HB 2693 Sheets
Relating to the registration of roofing contractors; authorizing a fee and providing penalties.

HB 2806 Geren
Relating to delinquent payment of an alcoholic beverage retailer's account for liquor.

HB 2818 Sheffield, Ralph
Relating to changing the wet or dry status in certain areas of a political subdivision.

HB 2953 Guillen
Relating to the ability of a state license holder to practice the person's profession.

HB 3038 Anderson
Relating to licensing and regulation of auctioneers; authorizing a fee.

HB 3558 Oliveira
Relating to intra-industry relationships between alcoholic beverage manufacturers, wholesalers, and retailers.
