HB 327 Dutton Relating to requiring notice and the dissemination of criminal history record information to the subject of the information in certain circumstances.

HB 708 Isaac Relating to the appointment of a deputy constable.

HB 1166 Villalba Relating to the change of the name of the Commission on Law Enforcement Officer Standards and Education to the Texas Commission on Law Enforcement.

HB 1677 Frullo Relating to reports of missing children or attempted child abductions and to education and training for peace officers regarding missing or exploited children.

Schaefer HB 2535 Relating to the exemption from certain security licensure of certain persons who provide security services on a volunteer basis at a private primary or secondary school or church or religious organization. HB 1656 Eiland | et al. Relating to funding for emergency medical air transportation provided to patients enrolled in the state Medicaid program; imposing a surcharge. HB 2050 Dutton Relating to the creation of a task force to conduct a study and develop recommendations to alleviate the incidence of gun violence in this state. HB 3143 Anchia Relating to the creation of certain offenses concerning firearm sales at gun shows; authorizing a fee. HB 2648 Herrero Relating to access to criminal history record information by a county tax assessor-collector. HB 3420 Lavender Relating to the carrying of firearms by certain off-duty employees of the Texas Department of Criminal Justice and the carrying of a handgun by a license holder in certain locations; authorizing a fee. HB 3412 Flynn Relating to the qualifications for certain positions with the Department of Public Safety of the State of Texas. HB 3433 Fletcher Relating to the regulation of certain private security companies and occupations; creating an offense. HB 3672 Fletcher Relating to the qualifications of a member of the Public Safety Commission. Phillips HB 3178 Relating to emergency management.
