A BILL TO BE ENTITLED

1 AN ACT  
2 relating to notice of residential services available for persons  
3 with intellectual disabilities.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 533.038, Health and Safety Code, is  
6 amended by adding Subsection (g) to read as follows:

7 (g) In addition to the explanation required under  
8 Subsection (d), the department shall ensure that each person  
9 inquiring about residential services receives:

10 (1) a pamphlet or similar informational material  
11 explaining that a state supported living center may be an option  
12 available to an individual who is eligible for those services; and

13 (2) information relating to whether appropriate  
14 residential services are available in the state supported living  
15 center located nearest to the residence of the proposed resident.

16 SECTION 2. This Act takes effect September 1, 2013.
