H.B. No. 2448

A BILL TO BE ENTITLED

1 AN ACT
2 relating to tuition for certain students residing outside of a
3 junior college district.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 130.0032, Education Code, is amended by
6 adding Subsection (b-1) to read as follows:

7 (b-1) The governing board of a public junior college
8 district shall allow a person who resides outside the district and
9 in the taxing district of a contiguous public junior college
10 district to pay tuition and fees at the rate applicable to a student
11 who resides in the district for enrollment at a campus located
12 within an area in which the person resides that is designated as a
13 super neighborhood by a municipality with a population greater than
14 two million.

15 SECTION 2. This Act takes effect immediately if it receives
16 a vote of two-thirds of all the members elected to each house, as
17 provided by Section 39, Article III, Texas Constitution. If this
18 Act does not receive the vote necessary for immediate effect, this
19 Act takes effect September 1, 2013.

18 provided by Section 39, Article III, Texas Constitution. If this
19 Act does not receive the vote necessary for immediate effect, this
20 Act takes effect September 1, 2013.
