Section 1001.101, Education Code, as amended by Chapters 1253 (H.B. 339) and 1413 (S.B. 1317), Acts of the 81st 7 Legislature, Regular Session, 2009, is reenacted and amended to 8 read as follows: 9 Sec. 1001.101. ADULT AND MINOR DRIVER EDUCATION COURSE 10 11 CURRICULUM AND TEXTBOOKS. (a) The commissioner by rule shall 12 establish or approve the curriculum and designate the textbooks to be used in a driver education course for minors and adults, 13 14 including a driver education course conducted by a school district, driver education school, or parent or other individual under 15 16 Section 521.205, Transportation Code. (b) A driver education course must require the student to 17 18 complete: (1) 7 hours of behind-the-wheel instruction in the

(1) 7 hours of behind-the-wheel instruction in the presence of a person who holds a driver education instructor license or who meets the requirements imposed under Section 22 521.205, Transportation Code;

(2) 7 hours of observation instruction in the presence
of a person who holds a driver education instructor license or who

3 (3) <u>30</u> [20] hours of behind-the-wheel instruction, 4 including at least 10 hours of instruction that takes place at 5 night, in the presence of an adult who meets the requirements of 6 Section 521.222(d)(2), Transportation Code.

7 SECTION 2. Section 545.424(a-1), Transportation Code, is 8 amended to read as follows:

9 (a-1) A person under 18 years of age may not operate a motor 10 vehicle [during the 12-month period following issuance of an 11 original Class A, B, or C driver's license to the person]:

12 (1) after midnight and before 5 a.m. unless the 13 operation of the vehicle is necessary for the operator to attend or 14 participate in employment or a school-related activity or because 15 of a medical emergency; or

16 (2) with more than one passenger in the vehicle under17 21 years of age who is not a family member.

18 SECTION 3. The change in law made by Section 1001.101(b), 19 Education Code, as amended by this Act, applies only to a driver 20 education course that begins on or after the effective date of this 21 Act. A course that begins before the effective date of this Act is 22 governed by the law in effect on the date the course began, and that 23 law is continued in effect for that purpose.
