(5) employees of a district attorney, criminal district attorney, or county or municipal attorney whose jurisdiction includes any criminal law or child protective services matters;

(6) officers and employees of a community supervision and corrections department established under Chapter 76 who perform a duty described by Section 76.004(b);

(8) police officers and inspectors of the United States Federal Protective Service; [and]

(b) Information that relates to the home address, home telephone number, emergency contact information, <u>date of birth</u>, or social security number of an individual to whom this section applies, or that reveals whether the individual has family members is confidential and may not be disclosed to the public under this chapter if the individual to whom the information relates:

(1) chooses to restrict public access to the information; and

(2) notifies the governmental body of the individual's choice on a form provided by the governmental body, accompanied by evidence of the individual's status.

(b) Information that relates to the home address, home telephone number, emergency contact information, <u>date of birth</u>, or social security number of an individual to whom this section applies, or that reveals whether the individual has family members is confidential and may not be disclosed to the public under this chapter if the individual to whom the information relates:

 chooses to restrict public access to the information; and

(e) All documents filed with a county clerk and all documents filed with a district clerk are exempt from this section, except that the county clerk or district clerk may redact the street address of an individual to whom this section applies from a document filed with the clerk without the necessity of requesting a decision from the attorney general under Subchapter G at the request of the individual, if that individual identifies to the clerk the specific document containing the address.
