House Bill (HB) 2092, as Filed by Representative John Zerwas - Relating to the road powers of the Fort Bend County Municipal Utility District No. 182

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill amends Special District Local Laws Code Section 8176.051(a) related to the Fort Bend County Municipal Utility District No. 182 (the "District") to specify that the District may construct, acquire, improve, maintain, or operate macadamized, graveled, or paved roads or turnpikes, or improvements in aid of those roads or turnpikes, outside (currently only inside) the District.
