Re: Responsibility of the Texas Commission on Environmental Quality (TCEQ) Pursuant to Article XVI, Section 59(d), Texas Constitution

House Bill (HB) 3720, as Filed by Representative Leighton Schubert - Relating to authorizing the Post Oak Savannah Groundwater Conservation District to use revenue from export fees to fund road and water infrastructure projects.

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill amends the enabling statute for the Post Oak Savannah Groundwater Conservation District (District), Chapter 8865, Special District Local Laws Code. The bill authorizes the District to use export fees to fund road and water infrastructure projects.




