Re: Responsibility of the Texas Commission on Environmental Quality (TCEQ) Pursuant to Article XVI, Section 59(d), Texas Constitution

House Bill (HB) 4137, as Filed by Representative Alma Allen - Relating to the qualifications of directors of the Spectrum Management District

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill repeals Special District Local Laws Code Section 3840.053 related to Spectrum Management District (the "District"). Special District Local Laws Code Section 3840.053 states, "[s]ection 49.052, Water Code, does not apply to the district." Water Code Section 49.052 specifies what constitutes as disqualification for a person serving as a member of a board of a district.
